DECREE OF MAYOR OF MOSCOW

No. 12-UM dated 5 March 202

On the introduction of the state of high alert

Due to the threat of the spreading in Moscow of the new coronavirus disease (2019-nCoV), pursuant to Subclause b, Clause 6, Article 4.1 of Federal Law No. 68-FZ dated 21 December 1994 On the protection of the population and territories from technological and natural emergencies:

1. To introduce the state of high alert in Moscow.
2. To compel the citizens who have visited the territories where cases of the new coronavirus disease (2019-nCoV) are registered:
 - 2.1. To report their returning to the Russian Federation, dates of staying in the said territories, as well as provide contact details to the hotline of Moscow at +7(495)870-45-09.
 - 2.2. In case of the onset of the first respiratory symptoms, to immediately request at-home medical assistance without visiting healthcare institutions.
 - 2.3. Abide by the instructions of health officers regarding maintaining isolation at home.
3. To compel the citizens returning from the People's Republic of China, the Republic of Korea, the Italian Republic, the Islamic Republic of Iran, the French Republic, the Federal Republic of Germany, the Kingdom of Spain, as well as other countries with an adverse coronavirus disease (2019-nCoV) spreading situation specified in the list approved by the Moscow Directorate of the Federal Service for Surveillance on Consumer Rights Protection and Human Wellbeing, to maintain self-isolation at home within 14 days from the return to the Russian

Federation (to avoid visiting their places of work, study and to minimise visiting public places), in addition to the measures specified in Clause 2 hereof.

4. To compel all employers conducting their activities within Moscow:

4.1. To ensure the measurement of employees' body temperature at workplaces, with the compulsory suspension from staying at the working premises of persons with a high body temperature.

4.2. To assist employees in maintaining self-isolation at home.

4.3. If requested by the Moscow Directorate of the Federal Service for Surveillance on Consumer Rights Protection and Human Wellbeing, immediately provide information on all contacts of the persons infected with the new coronavirus disease (2019-nCoV) related to the performance of such persons' duties and to ensure the disinfection of the premises at which the infected persons have stayed.

5. The Healthcare Department of Moscow:

5.1. To ensure the possibility of issuing medical disability certificates without the need for the persons specified in Clauses 2 and 3 hereof to visit healthcare institutions.

5.2. To arrange the priority rendering of medical assistance at home by healthcare institutions to patients with fever showing respiratory symptoms who have visited the territories in which cases of the new coronavirus disease (2019-nCoV) have been registered and to patients aged over 60, for which purpose to ensure the reinforcement of the mobile outpatient service with the employees of preventive care units, the city phthisiological service and with the resident physicians of higher education institutions.

5.3. To ensure the readiness of healthcare institutions rendering medical assistance on an inpatient and outpatient basis and rendering emergency medical assistance for the admission of and rendering medical assistance to patients with respiratory symptoms, the take-off of biological materials for coronavirus disease (2019-nCoV) testing.

6. Due to the currently conducted complex reconstruction of Infectious

Diseases Clinical Hospital No. 1, **A.Yu. Bochkarev**, Deputy Mayor of Moscow for Town Planning and Construction in the Government of Moscow, shall elaborate on the construction of an infectious disease center using quickly erectable structures.

7. The Commission of the Government of Moscow for the Prevention and Elimination of Emergency Situations and Fire Safety under my supervision shall ensure the coordination of the activities of the public bodies of Moscow, the local self-governance bodies in Moscow districts and of settlements within Moscow, as well as of organisations in Moscow.

8. **A.V. Rakova**, Deputy Mayor of Moscow for Social Development in the Government of Moscow – Chairman of the Command Center for the Prevention of the Importation and Spreading of the infection caused by the coronavirus disease (2019-nCoV) (hereinafter – the "Command Center"):

8.1. To ensure the twenty-four-hour operation of the Command Center until further notice.

8.2. To submit to Mayor of Moscow the report on coronavirus disease (2019-nCoV) spreading in Moscow and the number of the infected, including the newly detected cases of infection, on a daily basis.

9. I undertake to personally control the fulfilment of this Decree.
