Russian market of PowerGen Engineering: main tendencies

Construction of new power units with application of combined cycle (steam and gas) technologies with high efficiency of 57-62%

- Increase of contract price by 30% against prices in the beginning of 2007
- High-level load of manufacturing capacities for the manufacturers of main and auxiliary equipment
- **«Wave-type» staff shortage under stages of project implementation** (designers shortage is clearly tangible)
- Foreign power engineering companies come into the market as EPC(M) contractors (GAMA, Iberinko, Alstom)
