We represent interests of our members regarding the following issues: parallel imports, waste management, outstaffing (secondment), personal data protection, codes of conduct for automobile and pharmaceutical industries, consumer protection legislation, customs (e.g. TIRcarnets, authorised economic operators), IT, migration, insurance, banking, technical regulations, amendments to the mass media law and many others.

The AEB pays its considerable attention to a fruitful working relationship with the press as looking at the increase of AEB mentions in press if compared to the previous year, it is clear that these efforts were not in vain. Currently, AEB events are covered by both Russian (Kommersant, Vedomosti, Izvestia, RBC, The Moscow Times, 1 Channel, Interfax, Russia Today, TASS, etc.) and foreign (Bloomberg, BBC, BILD-Zeitung, Caijing, Der Spiegel, Deutsche Welle, Die Welt, DWN, El Mundo, El Pais, Euronews, Europa Press, La Tribune, Le Figaro etc.) media.

Our publications, the most important being the Position Paper and the AEB Business Quarterly, are currently being delivered to major organisations, embassies business centres and hotels in Moscow, Krasnodar, St. Petersburg and Brussels.

We would like to express our gratitude on behalf of all our members to the outgoing members of the Board, the Council of National Representatives, the Auditing Commission and all Committee Chairpersons for their hard work and dedication in representing and promoting the interests of AEB member-companies, and for their commitment to forging stronger economic ties between the EU and Russia. Through our committees, subcommittees and working groups, the AEB will continue to work actively for the benefit of European businesses operating in Russia.

As the next pages will demonstrate, the year 2015 was quite full of events. We hope that this annual report will show all our members that the AEB is in fact doing its uttermost best in lobbying interests of its member companies; and this is a tradition we most definitely intend to continue in the years to come.

### THE ASSOCIATION OF EUROPEAN BUSINESSES (AEB)

- was founded in 1995 by a number of companies operating in the Russian market, ambassadors of the EU member countries and the head of the European Commission's Representative Office in the Russian Federation;
- includes over 500 European companies active in Russia, from small-sized newcomers to major multinational corporations from all countries of Europe. The Association also includes a number of key Russian, American, Japanese and other companies;
- is a unique organisation developing cooperation between Russian and European business circles. The AEB mission is to improve the business and investment climate in Russia in the interests of its member companies and promote a favourable image of Russia abroad to facilitate the business development conditions inside the country and attract foreign investors;
- annually organises some 100 conferences, seminars, briefings and roundtable discussions dedicated to vital aspects of running a business in Russia. Regular speakers at the Association's dialogue with European Business include Ministers of the Russian Government, Members of the State Duma of the Russian Federation, heads of key economy agencies and organisations, heads of administrations of Russian regions, official representatives of international financial organisations, independent experts and leading European and Russian businessmen.

**Committees.** Committees are the backbone of the AFB. Members of the Association promote their interests via participation in various committees. There are currently over 65 committees, subcommittees and working groups representing companies from various industries. The AEB committees include the Agribusiness Committee, Airline Committee, Automobile Manufacturers Committee, Automotive Components Committees, Banking Committee, Crop Protection Committee, Energy Committee, as well as the Compliance & Ethics Committee, Energy Efficiency Committee, IT & Telecom Committee, Insurance & Pensions Committee, Health & Pharmaceuticals Committee, Machine Building & Engineering Committee, Finance & Investments Committee, Legal Committee, Migration Committee, Human Resources Committee, Taxation Committee, Customs & Transport Committee, Real Estate Committee, Safety, Health, Environment & Security Committee and others.

**Lobbying.** The Association promotes its members' interests by closely cooperating with the RF and the EU authorities and holding regular consultations with relevant officials. AEB's lobbying is based on the maximum transparency, high professionalism and a mechanism of reacting to new challenges which has been adjusted over many years.

**Consulting.** The Association engages European and Russian experts to consult Russian officials and its member companies in legal, financial and economic matters. In 2015, the AEB founded an Arbitration Court.

#### **MEDIA RELATIONS**

The number of press contacts continued to increase along with the development of AEB press relations. **Press-releases.** In 2015, the AEB communications department issued a number of press releases, including monthly press releases with the results of Russian car and LCV sales, the results of the annual AEB-Gfk Rus survey "Strategies and Prospects for European Companies in Russia", and messages about AEB lobbying activities and committee initiatives.

- There were twice as many press-clippings in 2015 than in 2014.
- The annual press reception for representatives of local and foreign mass media organisations took place in January 2015.
- In 2015, numerous mass media organisations mentioned the AEB over 23,000 times<sup>1</sup>.

#### **AEB Corporate Social Responsibility**

#### **Online activities**

In April 2015, the AEB announced the launch of its newly redesigned website www.aebrus.ru. - The AEB continued to publish the annual Membership Directory with a circulation of 3,000 copies. In 2015, information about member companies was listed in the AEB Membership Directory.



#### **COMMITTEE ACTIVITIES, 2015**

2015 was the 18th year of AMC operations in the AEB.

For the 9<sup>th</sup> year the committee continued to operate an online sales data exchange system for its members, which remains practically the only up-to-date and reliable source of passenger car and light commercial vehicle sales statistics in Russia. As always the 2014 results and forecast for 2015 were provided to the media at the AMC annual press conference which also provided the press the opportunity to talk to automobile company executives about important issues related to the automotive industry.

One of the key AMC member issues during the year was the practical implementation of the provisions of the Code of Conduct (CoC) developed and adopted by the AMC in cooperation with the Federal Antimonopoly Service and Ministry of Industry and Trade. By the end of 2015, 20 members had joined the Code of Conduct. To ensure compliance with its provisions, the committee together with the FAS analysed the results of status surveys conducted both by the FAS and the AMC. The analysis revealed a misinterpretation of some of the provisions by its members which served as the basis for developing recommendations on the implementation of the CoC. The recommendations are helping the goals declared by the CoC members to be met.

In connection with the above issue the AMC was deeply involved in the development and promotion of amendments to the Consumer Protection Law (CPL), which can eliminate the risks run by manufacturers/distributors and CoC members arising after the full implementation of the Code of Conduct.

On 01 January 2015, the new Customs Union Technical Regulation, TR CU 018/2011, "On the Safety of Wheeled Vehicles" entered into force. It requires the mandatory equipping of new vehicle types with an emergency call system/device. During the year, the AMC held extensive discussions with certification bodies on the practical implementation of the TR CU requirements. In addition to this, the AMC certification working group initiated the formation of a temporary expert body consisting of AMC members, European experts, NAMI, and others, with the goal of drawing up a draft GOST on roll-over, and in so creating the framework for tests to ensure the proper operation of the emergency call system/ device in the event of a car roll-over. The draft became available for public discussion at the end of November 2015. The AMC started its review and developed comments. The roll-over test will become mandatory from 01 January 2017, and it is a new challenge for manufacturers to comply with the new requirements in time.

The committee focused on other issues related to the emergency call system: validity of the vehicle type approval after 01 January 2017 (if their expiration date exceeds it) due to the mandatory equipping of all vehicle types with the ECS from this date; crash tests for cars supplied in small volumes; the recognition of foreign QM certificates and other related topics.

Another very important issue on the agenda of the committee was the upcoming introduction of vehicle digital passports in the Eurasian Economic Union. The AMC members took part in discussions with the responsible governmental bodies and submitted comments and proposals to the Eurasian Economic Commission and Ministry of Industry and Trade of the RF in order to avoid the unnecessary increase in the amount of information required from the manufacturers/distributors for the digital system, and to simplify procedures and eliminate discrepancies in the basic EEC decisions. During the year, the committee representatives participated in other important events, where they spoke on behalf of the AMC, such as the Russian Automotive Forum organised by Adam Smith conferences, the "Rosavtodealer-2015" conference organised by ROAD (the Association of Russian Automobile Dealers), and the 93<sup>rd</sup> International Scientific-Technical Conference of the Association of Automobile Engineers "Technical regulation of automotive vehicles".

The other main issues on the AMC agenda in 2015 were:

- The 65% increase in the disposal fee. The committee argued against its effectiveness especially in the current economic situation.
- Customs problems with the importation of parts put the provision of after-sales customer service at risk.
- Implementation of the car safety recall campaign. The committee highlighted the problem of raising awareness among relevant car owners about the campaign due to the inability to obtain the personal (contact) data of the current owner.

#### External contacts and communication:

During the year, the AMC published monthly press-releases on car sales statistics that are widely used by the automotive and business media in Russia and outside the country. Press coverage of issues addressed by the AMC and its activities in general expanded further in 2015.

An AMC representative participates in the work of the UN EC Working Group on the development of the UN rules on a permanent basis.

The committee continued to strengthen contacts with national and international automotive associations: ACEA (European Automobile Manufacturers' Association), OAR (Association of Russian Automakers), OICA (International Organisation of Motor Vehicle Manufacturers), ROAD, VDA (German Association of the Automotive Industry), as well as with local authorities and industry officials.

Apart from being in close contact with the Ministry of Industry and Trade, the committee held several meetings focused on briefing EC representatives on industry developments within the country. Two meetings with the European Commission, including one with the Head of the EU Delegation in Russia. Two meetings with the European Automobile Manufactures' Association (ACEA). Three meetings with OICA.

#### **COMMITTEE ACTIVITIES, 2015**

The committee's key functions remain unchanged and include the identification of common goals and problems for the committee member companies, based on which the current work priorities for the committee are developed and formulated. Other important issues remain: receiving state support for foreign investors; gaining full access to the existing instruments for supporting and developing the auto parts sector; the further development of the localisation of auto parts, coordinated work aimed at increasing the localisation of automobiles together with the Automobile Manufacturers Committee; the application of competitive, efficient, and environmentally safe technologies and knowhow; the protection of intellectual property; coverage in the legislative and economic spheres, trade fairs, and other areas linked to the operating activities of the committee members.

The committee members participated on privileged terms in the 6<sup>th</sup> International Forum "The Russian automotive industry and development of auto components in the new environment – IMAF-2015", which was organised in cooperation with the international exhibition operators Messe Frankfurt and ITE, and was held on 25 August 2015.

#### **COMMITTEE ACTIVITIES, 2015**

In 2015, the committee continued its cooperation with key partners, namely:

- The committee continued its dialogue with the regulator the Central Bank of the Russian Federation: on 3 March, the committee held a meeting with Artem Sychev, Deputy Head of Information Security at the Bank of Russia, regarding the implementation of the law on personal data protection for the banking sector (jointly with the FIAC Working Group on Financial Institutions and Capital Markets); on 15 May, the committee held a meeting with representatives of the Financial Market Development Department to discuss the registration and recognition of the National Clearing Center (NCC) by the European Securities and Markets Authority (ESMA); on 24 June, senior representatives of member banks met with Ksenia Yudaeva, First Deputy Governor of the Central Bank, to discuss the Central Bank regulations and policy and challenges that foreign banks face in the current environment (the committee is in constant communication with the Central Bank on this issue). Also, the committee sent a number of letters with comments on the improvement of banking legislation and requests for clarifications to the Central Bank.
- The committee liaised with the government, Ministry of Finance, Ministry of Economic Development and sent comments and requests on issues related to banking legislation.
- The committee continued its collaboration with the State Duma and, in particular, with the State Duma's Committee on Financial Markets. The committee's representatives (members of the Expert Council on Banking Legislation and Auditing under the State Duma's Committee on Financial Markets) participated in Expert Council meetings.

• The committee initiated cooperation with the European Commission, namely with Jonathan Hill, Commissioner for Financial Stability, Financial Services and Capital Markets Union, European Commission, regarding the registration and recognition of the National Clearing Center (NCC) by the European Securities and Markets Authority (ESMA). The issue was discussed with Jonathan Hill during the AEB Board mission to Brussels in March 2015.

A group of CEO-level representatives of the Committee's member banks held regular meetings to discuss ongoing work and developments, including: a business breakfast with the participation of Edgars Puzo, Chairperson of the Working Group on Data Protection and IT & Telecom Committee, and Yulia Labutina, Member of the Working Group on Data Protection; a business breakfast with Ksenia Yudaeva, First Deputy Governor of the Central Bank.

The committee strengthened cooperation with other AEB Committees and Working Groups, namely: the Automobile Manufacturers Committee, the Automotive Components Committee, the IT & Telecom Committee and Working Group on Data Protection, the Heating Systems Manufacturers Working Group, the Taxation Committee, etc. Also, the committee chairman, committee representatives and coordinator participated in a number of meetings of the Working Group on Financial Institutions and Capital Markets of the Foreign Investments Advisory Council and continued working with it, most notably on the implementation of the law on personal data protection.

Furthermore, on 25 August 2015, Joerg Bongartz, Chairman of the Banking Committee, participated as a moderator at the session "Financing and Refinancing in the Automotive Industry" at the 6<sup>th</sup> International Forum IMAF-2016 "The Russian automotive industry and development of auto components in the new environment" (as part of the exhibition "MIMS supported by Automechanika").

In 2015, the following topics were discussed in the committee: the implementation of the law on personal data protection for the banking sector; currency control; renumeration rules; proposals for banking legislation; the registration and recognition of the National Clearing Centre (NCC) by the European Securities and Markets Authority (ESMA); Russian FATCA; the possible exclusion of foreign controlled banks from the perimeter of banks authorised to hold the deposits of state controlled entities; anti-money laundering (AML) legislation, and others.

The Commercial Vehicles Committee (CVC) was founded at the end of 2008 as a spin-off of the Automobile Manufacturers Committee (AMC) in order to focus on the specific needs of commercial vehicle manufacturers in the Russian Federation. The main issues discussed by the committee in 2015:

#### **Definition of the country of origin**

Of particular concern are the government ideas reported in the media to extend the restrictions imposed on companies with state participation and participating in projects with a significant share of public funding. Such a decision would lead to the further restriction of competition in the market, which today has been seriously affected by a more than twofold drop in sales.

The committee insists that the localisation of production must be supported by substantial incentives that have a positive effect on the economy of projects in this area. Unstable rules of the game, informal restrictions regarding procurement for public companies with vague criteria, import substitution based solely on bans and restrictions are all having a very negative impact on the development prospects of international brands in Russia. From our part we are ready in every way to strengthen cooperation with the Russian government and participate in the growth of not only the market but also the production of commercial vehicles in the country.

### The ban on the sale of vehicles that do not comply with the fifth emissions class

#### **Equipping with emergency service call devices**

The Technical Regulations of the Customs Union require the mandatory equipping of emergency service call devices in 2016 for buses and lorries carrying dangerous goods. At the same time there is an extremely limited supply of certified devices on the market today that can be used to fit the equipment. As a result the certification of models newly introduced to the market is more difficult, and this poses a threat to company business plans.

The committee supports the efforts of the Russian government to improve road safety in the country through modern high-tech solutions. However, it is clear that the introduction of the new requirements should not lead to the disruption of the work of companies. Additional regulatory risks are unacceptable in the current deep crisis in the commercial vehicles market.

#### **Increased disposal fee rates**

The committee took part in the International Commercial Vehicle Auto Show COMTRANS/15 which was held on 8–12 September in Crocus Expo, Moscow.

### **COMMITTEE ACTIVITIES, 2015**

The Construction Equipment Committee (CEC) was established in February 2008 to bring together and represent the interests of the CE industry players in Russia.

Retail sales statistics are considered as crucial data by all CE manufacturers. The AEB Construction Equipment Committee statistics programme has proven its effectiveness since its inception in 2008. Today, companies such as Caterpillar, Chetra, CNH, Doosan, Hidromek, Hitachi, JCB, John Deere, Komatsu, Kraneks, Liebherr, RM-Terex and Volvo are highly satisfied with the results of the programme. In 2013, Bell Equipment joined the programme. In 2014 Doosan and Hyundai Heavy Industries started reporting. The reports are available in the Russian Federation at both the federal district and administrative region levels. It is also worth mentioning that the committee also started reporting on Kazakhstan in January 2014. Azerbaijan is considered a potential next step in the programme's extension.

The main issues discussed by the committee in 2015:

Disposal fee for off-road trucks, fee for the whole of construction equipment.

#### Localisation

The committee worked with the Ministry of Industry and Trade of the Russian Federation to amend the Draft Resolution "On the approval of the criteria for classifying industrial products as products which have no counterparts produced in the Russian Federation, and the criteria for classifying industrial products as products produced in the Russian Federation."

### Unlimited liabilities in terms of state procurement contracts

The committee cooperates with other national construction equipment industry associations. In 2009, the AEB CEC became a member of the Committee for European Construction Equipment (CECE) and it participates annually in CECE summits. In April 2013, the AEB CEC and KOCEMA (Korea Construction Equipment Association) signed a memorandum of understanding. KOCEMA invited CEC to make a presentation about the Russian construction equipment market in September at Conex Korea 2014.

### **COMMITTEE ACTIVITIES, 2015**

The AEB Construction Industry & Building Material Suppliers Committee represents a variety of businesses with very heterogeneous industrial and commercial backgrounds and with a diversity of interests, but which all work with construction materials. This committee was established in 2010 with the belief that there are many issues that need to be monitored and discussed, and the main focus was on producers of building materials.

In 2015, the committee concentrated on building a common position on the following issues:

- technical standards and regulations;
- environmental sustainability and green standards;
- technical control and construction guarantees;
- energy efficiency in construction;
- product certification and counterfeited products;
- transparency and reliability of information referring to construction materials;
- unfair competition and tax dumping;
- vocational education and training centers;
- "best available techniques" guides (BREFs);
- gas supply in Russia.

The committee members strongly believe that a dialogue between experts with different backgrounds and government officials can be of benefit to the Russian construction industry.

On 1 October 2015, Antonio Linares, Chairman of the Committee, participated in the AEB Conference "Real Estate Day" where he moderated the session "Investors in Russia: why it was worth it and why it is still worth it". Experts from big European companies shared their company growth plans in Russia. The moderator and speakers: 1) discussed the development of the real estate sector in terms of evaluating the growth of the middle class in Russia; 2) compared real estate and construction material prices in Russia to European prices; 3) discussed the factors that can help their business become more competitive and efficient; 4) discussed housing for rent as an efficient social model and exchanged their

suggestions for the Government to guarantee affordable housing.

In 2015, the Heating Systems Working Group of the committee continued to gather sales statistics.

In 2015, the committee updated its online catalogue, which contains information on the committee member companies activities, and their products and services (available on the AEB website).

#### **Anti-Counterfeiting Activity**

On behalf of the CPC a presentation on the current results and plans of the anti-counterfeiting work on the Russian Crop Protection market was made at the Third International Forum Anticounterfeit held in Minsk on 16–17 December.

### **Container Management Scheme (CMS)**

Being environmentally responsible companies, the CPC members initiated a CMS pilot project in the Voronezh region to adapt proven European CMS principles to the Russian environment. The initiative was supported by the Voronezh Region Government and officially recognised by the Memorandum of Cooperation to Implement the Pilot Project between the AEB, the Russian Union of Crop Protection Products (CPP) Manufacturers and the Voronezh Region Government in 2012–2015.

The project has seen increasing success: in 2013, 100 tons were collected and recycled; in 2014–2015 the area of CPP container collection was expanded by including the other regions of the Central Black Soil area (Belgorod, Kursk, Lipetsk, Tambov) and eight hundred tons of mostly correctly rinsed containers were collected and recycled (four hundred per year). The positive results of the pilot project were presented at:

European Crop Protection Association Workshop on CMS issues – 19–20 March in Thessaloniki, Greece; First International Recycling Forum – 4–6 November in Wiesbaden, Germany.

The pilot project has shown the **desirability of producer responsibility** by establishing a managing company.

#### Contribution of international companies in Russian agriculture.

This year, companies elected to put more effort into creating a solid evidence basis for the work of international companies in Russian agriculture. To implement it a Communication and Information Support Inter-committee Working Group

was created. This Working Group initiated a market survey aimed at determining the contribution of international Crop Protection and Seed producers in the development of Russian agriculture. It was based on large-scale interviews of farmers from more than 400 farms and in-depth interviews with the heads of big agroholdings and experts (industry union directors and scientists).

More than a half of the respondents recognised the contribution of international companies in implementing innovative technologies: 48% in the newest selection developments; 42% in the development of new active substances. This and other key results are presented in the Position Paper that will be sent to the authorities and mass media in the beginning of 2016.

The survey results complemented with the analysis of educational programmes organised by the companies were presented at:

Ever since it was established, the Customs & Transport Committee and its members have been working on identifying challenges in respect of the application of customs laws. Currently, intensive work is in progress on the identification of gaps and discrepancies at the Eurasian Economic Union (EAEU) level of legislation and the level of national regulatory acts published for the development of provisions and institutions within the EAEU Customs Code. Work is also in progress to improve previously enacted regulations in the sphere of customs legislation within the framework of regulatory impact assessment.

The purpose of the committee's work is not only to identify gaps and discrepancies in legislation, but also to jointly develop recommendations on their removal with experts from the business community, which are mainly aimed at improving regulatory documents.

Experts at the Customs & Transport Committee analyse existing documents which regulate customs and transport activities on an on-going basis, as well as drafts of new regulatory documents. Based on the analysis, the committee develops risk management recommendations for businesses and prepares proposals for amending existing laws, as well as amendments to drafts of regulatory documents.

The committee acts as an intermediary in constructive dialogue between the regulatory bodies and the business community on issues related to customs and transport in order to increase the effectiveness of government control in the aforementioned areas and to improve the business environment.

### **COMMITTEE ACTIVITIES, 2015**

The AEB Energy Committee acts as an interface on business opportunities and issues of concern for European energy companies operating in the Russian Federation. The committee maintains and develops links to the relevant state authorities in Russia, such as the RF State Duma, Ministry of Energy, Ministry of Finance and Ministry of Economic Development. The committee also acts as an interface between the European energy industry and Russian companies, such as Gazprom, and others.

The AEB Energy Committee maintains its cooperation with bilateral and multilateral entities in Russia, such as the EU – Russia Industrialists Roundtable (IRT), European Business Congress (EBC), Petroleum Advisory Forum (PAF), and Foreign Investment Advisory Council (FIAC), promoting active cooperation on business-to-business and business-to-government levels. The AEB Energy Committee supports the AEB's position as an official partner of the annual Russian Petroleum and Gas Congress (RPGC) in Moscow through participation in its Programme Committee, delegating its members as chairmen and speakers at the RPGC. The committee's activities are focused on energy policy strategic issues, the investment climate, energy market conditions, and environmental protection issues, including global climate change.

One of the important sources of information and tools of influence for the committee is its regular Position Paper, which is a highly professional document reflecting the views and approaches of European companies towards the obstacles experienced when doing business in Russia and with proposals for real solutions. The Position Paper is widely distributed among petroleum and energy sector stakeholders both in Russia and abroad, including the EU headquarters in Brussels.

The committee advocates that EU-Russia relations on energy matters should be based on stability in the strategic outlook, mutual gain and delivery of commitments. Such relations must include a balanced and transparent approach to the security and diversity of energy supply and demand, commercial attractiveness and reciprocity.

On 14 April, 7 July and 27 October 2015, the committee held its CEO breakfasts.

### **COMMITTEE ACTIVITIES, 2015**

The Energy Efficiency Committee was established in 2009. It was a success from the very beginning, with service and energy sector companies becoming members. Representatives of the committee took an active part in drafting the new legislation on energy efficiency (EE) and energy saving.

In 2015, the Energy Efficiency Committee positioned itself as one of the authoritative bodies to which AEB members can turn to get information on the general energy efficiency environment and business opportunities in Russia. The committee members participated in various EE seminars and conferences and were often asked to speak at these events.

During the year the committee members kept each other informed about their work in EE. One of the main achievements of the committee this year was the bilingual Energy Efficiency Guide, which was published in November 2015 and was a great success.

The committee has continued this year with "Speed Dating", which it launched three years ago, and which promotes inter-committee relations. This event consists of organising short meetings (10 minutes) between companies that may be interested in getting to know each other better and potentially do business together (as a partner, a client, or others). This year Speed Dating was held at International Forum Energy Efficiency and Building Automation.

The committee members participated in the International Forum on Energy Efficiency and Energy Saving which took place in Moscow in November 2015.

The committee has working relations with the Russian Federation (RF) Ministry of Energy, RF Duma Committee for Energy and Energy Efficiency, Russian Energy Agency, RSPP Committee for Energy Policy and Energy Efficiency and U4E (Union of French Enterprises for Energy Efficiency and Ecology).

One of the key committee projects for 2015 was the eighth annual survey "Strategies and prospects for European companies in Russia". The survey has become a highly valuable source of first-hand information that gives an overview of the investment potential and opportunities in Russia and highlights the key challenges faced by AEB member companies, as well as the strategies adopted while doing business in Russia. The results of the survey were announced on the eve of the St. Petersburg Economic Forum: the official presentation was held on 16 June 2015 in Moscow and on 17 June 2015 in St. Petersburg. The survey and its results were well cited in the media.

Other important events included the annual briefing by Boris Titov, Presidential Commissioner for Entrepreneurs' Rights (30 October 2015). During the event Boris Titov spoke about the report "Economy of growth" and proposals to improve the business and investment climate in Russia, as well as about the achievements, prospects and barriers in respect of entrepreneurs' rights. He also openly and enthusiastically answered numerous questions regarding the business mentality in Russia, import substitution, participatory construction and its insurance, institutions for financing small and medium-sized companies, illegal actions of state authorities, and others.

Another significant initiative was the organisation of regular events devoted to updates on the economy and sanctions. In 2015, the committee organised two events, namely "Where are we headed? Deoffshorisation, sanctions, the economy and some practical crisis management advice" on 12 February, and "How normal is the new normal?" on 15 October.

The committee strengthened cooperation with other AEB Committees and Working Groups, namely: the North-Western Regional, Automobile Manufacturers, Taxation, Commercial Vehicles, Construction Equipment Committees, Hotels & Tourism Working Group, and others. Also, Stuart Lawson, Chairman of the Committee, participated as a co-chair and co-moderator at the briefing by Gabriel Di Bella, Resident Representative of the International Monetary Fund in the Russian Federation – "Russia: Recent economic developments & challenges" held on 21 October 2015.

To cover leasing issues, the Finance & Investments Committee has a Leasing Subcommittee chaired by Sergey Ivanov, General Director, IKB Leasing.

In 2015, the AEB Leasing Subcommittee discussed and worked on the following issues: the accounting standards for rent/lease (PBU Arenda); draft law No. 675906-6 (after the adoption of 32-FL dated 08.03.2015) on thin capitalisation (art. 269 of the Tax Code); automotive issues (paid parking, GIBDD fines, corporate car fleet and labour inspections, transport tax, state subsidies for the financing of vehicle sales, and others) including a joint meeting with the Automobile Manufacturers Committee on these issues (23 June 2015); collection of payments (incasso); property tax when purchasing from related parties (jointly with the AEB Taxation, Commercial Vehicles, Construction Equipment, Automobile Manufacturers Committees); state support measures (subsides) for automobile manufacturers (including car leasing); withdrawal of leased assets; risks related to the sanctions; the practice of the Supreme Court on leasing; implementation of the new edition of the law on personal data protection in leasing companies; the pledge of leased assets; new changes to contract law provisions in the Civil Code and implications for the leasing industry; balance of mutual obligations in case of the early termination of lease contracts and use of auctions; bankruptcy of lessees; issues related to anti-money laundering (AML). The Leasing Subcommittee continued collaboration with the Ministry of Economic Development (in particular, with the Department on Investments Policy and Development of the Private Public Partnership): the Subcommittee Chairman and representatives participated in the work and meetings of the Working Group on Leasing Development under the Ministry.

### **COMMITTEE ACTIVITIES, 2015**

On 12 March 2015, the AEB Health & Pharmaceuticals Committee took part in the Round Table "The Pharmaceutical Market: Creation of Fair Play Rules on the Pharmaceutical Markets of the BRICS and CIS countries". The event was dedicated to the discussion of the existing antitrust problems on the pharmaceutical market which is regarded as one of the most complex multilateral markets. The event took place at the Federal Antimonopoly Service (FAS) of the Russian Federation and was opened by Igor Artemiev, Head of the FAS.

On 26 March 2015, the AEB Health & Pharmaceuticals Committee held its round table at the VI Northern Dimension Forum. The event was dedicated to the topic "Pharmaceutical manufacture localisation in the new environment: a field for investment experiments and innovation growth". The event was co-chaired by Sergei Smirnov, Chairman of the AEB Health & Pharmaceuticals Committee, Chairman of the Board, OOO Novo Nordisk, as well as Alexander Borisov, General Director, OJSC Polysan. The participants included regional administration officials, businesspeople and experts from the pharmaceutical industry. Pavel Tarakanov, Vice Governor of the Tyumen region, Head of the Representation Office of the Tyumen region in the Federal Bodies of Governance, presented the state support mechanisms for investment projects in the pharmaceutical industry in the Tyumen region. Elena Petrova, Head of the Department for the Pharmaceutical-Medical Industry Cluster and Radiation Technologies, St. Petersburg Technopark OJSC – Cluster Development Centre of St. Petersburg, spoke on state support for local pharmaceutical manufacturers in the North-Western Federal District. Ivan Vasilenko, General Director, Accredited Laboratory Olpharm, touched upon the necessary conditions for the innovative

development of the pharmaceutical industry in Russia, while Evgeny Kardash, Executive Director, Polysan OJSC, shared the company's experience of localisation in Russia and abroad.

On 10 April 2015, the AEB took part in the Round Table "The localisation of pharmaceutical production in Russia: yesterday, today and tomorrow" which took place in the Kaluga pharmaceutical cluster. The AEB was represented by Frank Schauff, AEB CEO, and Sergey Smirnov, Chairman of the AEB Health & Pharmaceuticals Committee, Vice President, Novo Nordisk (Russia & CIS). The meeting was dedicated to issues such as localisation in the new economic conditions; the definition of a local product: current status and prospects; long-term contracts with pharmaceutical manufacturers; parallel imports in the Russian Federation, and the fight against counterfeiting and the harmonisation of standards in the Eurasian Economic Union. The event was co-organised by the Association of Russian Pharmaceutical Manufacturers, the Kaluga Regional Government and the roundtable of the EU-Russia Industrialists. The attendees included representatives of relevant ministries: the Ministry of Health of the Russian Federation, the Ministry of Industry and Trade, regional ministries, representatives of the NP Kaluga Pharmaceutical Cluster as well as representatives of pharmaceutical companies. The conclusions of the event were submitted for the attention of the State Council of the Russian Federation. The meeting followed the inauguration ceremony of Novo Nordisk's manufacturing facility in Kaluga.

On 25 May 2015, the committee presented the first draft of the Code of Conduct for pharmaceutical producers at the Expert Council of the Federal Antimonopoly Service. The meeting took place at the FAS and was chaired by Igor Artemiev, Head of the FAS. The AEB was represented by Frank Schauff, AEB CEO; Sergey Smirnov, Chairman of the AEB Health & Pharmaceuticals Committee, and the members of the Working Group (WG) on the Code of Conduct of the Health & Pharmaceuticals Committee.

The WG had been working on the Code of Conduct since November 2014 in close cooperation with the FAS. At the meeting a public discussion was held on the Code of Conduct involving experts, representatives of professional associations and pharmaceutical companies. The Code of Conduct aims at establishing internal rules for the self-regulation of the pharmaceutical business in Russia, and fair competition in the industry.

On 25 November 2015, the committee met Alexey Alekhin, Deputy Director of the Department of Pharmaceutical and Medical Device Industry Development, Ministry of Industry and Trade, to discuss issues related to localisation.

In December 2015, a Working Group on price regulation was established within the AEB Health and Pharmaceuticals Committee to provide expert support to the Federal Antimonopoly Service, which took over the responsibility for defining tariff regulation in the pharmaceutical market.

On 20 October 2015, the WG on drugs pricing met Timofey Nizhegorodtsev, Head of the Department for the Protection of Competition in the Social Sphere and Trade of the FAS. The topic of discussion was the development of approaches towards a new price regulation methodology.

On 21 December 2015, Sergey Smirnov, Chairman of the Committee, took part in a meeting between the AEB delegation and FAS represented by Igor Artemiev, Head of FAS. The meeting was dedicated to import-substitution issues, including the pharmaceutical sector.

During 2015, the WG on the Code of Conduct for the pharmaceutical industry held regular internal meetings and consultations to discuss the Code of Conduct with the Federal Antimonopoly Service (Igor Artemiev, Head of FAS, and Timofey Nizhegorodtsev, Head of the Department for the Protection of Competition in the Social Sphere and Trade of the FAS), as well as different professional associations such as Innovative Pharma, the Union of Professional Pharmaceutical Associations, AIPM, ARPM, the Non-commercial Partnership Contributing to Competition in Russia, and others.

On 29 January 2015, the AEB open event "HR solutions in uncertain times: doing more with less" was held. It was organised by the AEB Assessment, Training & Development Subcommittee. The economic crisis threatens companies not only with financial problems and loss of market position but also the loss of skilled personnel, without whom it is impossible to overcome the crisis. Numerous studies have concluded that for people with satisfactory salaries, non-financial motivators are more effective than extra cash in building long-term employee engagement in most sectors, job functions, and business contexts. The event "HR solutions in uncertain times: doing more with less" was devoted to the practices the leading companies apply in uncertain times: non-material rewards and motivation – a customised and focused approach in learning and development. The event was moderated by Irina Zarina, Chairperson of the AEB Assessment, Training & Development Subcommittee, Managing Director, CEB SHL Talent Measurement Solutions.

On 17 February 2015, the Relocation Subcommittee of the AEB HR Committee held its annual Relocation Conference "Bringing Expats to Russia". The event has been held for the last eight years and is focused on the latest developments in property and relocation, corporate relocation policies, settling down in Moscow, the hotels and serviced accommodation market, schooling, support systems for families, departure services, immigration and labour law, employment of foreign nationals in Russia, etc. This year the conference "Bringing expats to Russia" was a half-day event organised in an interactive format. The conference consisted of three sessions which focused on the latest trends and challenges in the following sectors:

- Session 1: The relocation industry and rental market.
- Session 2: Outbound relocations.
- Session 3: Recent legislative developments in immigration and labour law.

On 9 April 2015, the AEB HR Committee held its 12<sup>th</sup> Annual HR Conference "HR fitness: doing more with less". It was focused on the practices that leading companies apply in uncertain times in the following sectors: recruitment, compensation & benefits, assessment, training & development, and labour law. The discussion in parallel sessions was devoted to the following topics:

- Compensation & benefits: remuneration strategy in crisis times.
- No pain no gain. Creating better talent management during economic crises.
- Key imperatives for HR in assessment, training & development. The changing nature of work.
- Statutory Russian immigration and labour regulations: new developments for the future.

The panel discussion of CEOs "HR During Uncertainty – A CEO's Standpoint" was a focal point of the programme, which closed the conference. The panelists discussed how their companies are doing in Russia at the moment.

On 26 May 2015, the AEB Safety, Health, Environment & Security and HR Committees held the workshop: "Security and legal aspects of recruitment and labour conflicts." The event gave HR and security professionals the opportunity to share their best practices in pre-employment screening and background checks and the resolution of labour conflicts. The workshop attendees were given the opportunity to make a case analysis and discuss its possible solution with the speakers: Evgeny Reyzman, Deputy Chairman of the Labour Law Subcommittee, Counsel, Baker&McKenzie, Mikhail Balev, Chairman of the Security Subcommittee, Business Development Executive, MIG Business Security Strategies, and Dmitry Budanov, CEO, Elite Security Holding Company. The meeting was co-moderated by Mikhail Balev and Michael Germershausen, Chairman of the AEB HR Committee, Managing Director, Antal Russia.

On 8 September 2015, the Recruitment Subcommittee of the AEB HR Committee held its open event "HR in social networks". Finding job candidates with the skills your company needs can be a challenging task for any HR professional. That is why HR managers, recruiters and hiring managers are now using social networks, which offer certain benefits that can make a big difference in the recruitment process. Social media can also help companies streamline employee engagement, keep an eye on the competition and perform a variety of other HR functions.

At the event, the speakers discussed the following topics: the users of social networks in Russia, tools applied by companies when using social networks for HR purposes, the difference in the perception of professional social networks between the recruiter and the candidate, secrets of effective communication in social networks, how to gain the interest of the right professional, social networks as a competitive advantage for an employer, social network best practices. The event was moderated by Dennis Kaminsky, Chairman of the AEB Recruitment Subcommittee, Partner, FutureToday.

On 20 October 2015, the AEB HR Committee and the Assessment, Training & Development Subcommittee held its open event "Talent management: survival mode?". The participants exchanged views on the challenges in terms of talent management today and what changes need to be made to the approaches of HR specialists in this respect. The event provided a platform for the discussion of the personal data law and its impact on the use of Talent Management Systems. The experience of gaining internal expertise through the "employees teach employees" training programme was also covered by the speakers of the event with a successful case study.

On 17 November 2015, the AEB HR Committee held its annual business meeting "Overview of salary surveys in Russia", organised by the AEB Compensation & Benefits Subcommittee. This is the 19th consecutive year the event has been held and it followed a panel discussion format. Russia's major salary survey providers updated the audience on the current trends in Russia's labour market and salary surveys. The following topics were covered by the speakers: remuneration and headcount: actual changes and plans, key approaches to HR-strategy; staff efficiency: management through incentive plans; reduction of company expenses during the crisis; salary reviews during the year; traditional salary surveys from the point of view of attracting and retaining staff; general guidelines for conducting salary surveys during market turbulence and uncertainty, etc. The event was moderated by Olga Gracheva, Chairperson of the AEB Compensation & Benefits Subcommittee, Senior Manager, People Advisory Services, EY.

On 8 December 2015, the AEB HR Committee held an open event, "Application of Federal Law No. 116-FL on the ban on 'Zayomny Trud' and rules for the accreditation of employment agencies for the right to engage in labour leasing activities: expected consequences for employees and employers after 1 January 2016", organised by the AEB Labour Law Subcommittee. The event was moderated by Olga Bantsekina, First Deputy Chairperson of the AEB Board, Chief Representative, Coleman Services UK. In the first part of the event Rostrud representatives briefed the audience on the rules for the accreditation of private employment agencies for the right to engage in labour leasing activities. Rostrud reiterated that to ensure uninterrupted work as required by law, employment agencies must submit the necessary documentation before 31 December, otherwise they will not be permitted to engage in the aforementioned activities. The second part of the event was conducted via a panel discussion with the participation of Olga Bantsekina, First Deputy Chairperson of the AEB Board, Chief Representative, Coleman Services UK; Liudmila Shiryaeva, Chairperson of the AEB Migration Committee, Government Relations Director, Tax & Law; Julia Borozdna, Chairperson of the AEB Labour Law Subcommittee, Partner, Pepeliaev Group; Evgeny Reyzman, Deputy Chairperson of the AEB Labour Law Subcommittee, Counsel, Baker & McKenzie. The panelists provided their interpretation of the possible risks and advised on how to proceed once Federal Law No. 116-FL coming into force on 1 January 2016.

### **COMMITTEE ACTIVITIES, 2015**

In 2015, the committee continued to develop cooperation and held regular meetings with key state partners, in particular:

• The committee strengthened cooperation with the regulator – the Central Bank (in particular, with the Insurance Market Department at the Central Bank). The committee regularly provided commentary and proposals to improve insurance regulation and sent a number of requests for clarifications on insurance issues to the regulator. In 2015, the committee held a number of meetings with representatives of the Insurance Market Department to discuss the following issues: the new chart of accounts, specialised depositories, the replacement of license forms, asset quality, issues related to OSAGO, curators for insurance companies, issues related to the sanctions, internal audit and control, financial ombudsman, court and legal practice related to the insurance business, anti-money laundering (AML) regulation of insurance activities, electronic insurance and identification of clients, the Bureau of Credit Histories, insurance fraud, the resolution of the RF Supreme Court on the application of OSAGO legislation by courts, the Central Bank's draft regulation on the solvency margin for insurance companies, the "cooling-off" period, the national reinsurance company and the draft law on it. Vladimir Sukhinin, Deputy Committee Chairman, is a member of the Central Bank's Expert Council on Insurance and regularly took part in the Expert Council meetings and activities.

- The committee maintained a dialogue with the Ministry of Finance, which tends to react positively to proposals made by the committee. This year the committee collaborated with the Ministry on the main regarding the issue of the national reinsurance company.
- The committee continued to cooperate with the Federal Antimonopoly Service (FAS), primarily in respect of the "cooling-off' period and the national reinsurance company. Four committee representatives are members of the Expert Council on the Protection of Competition in the Financial Services Market (section on the insurance services market) under FAS Russia and regularly take part in its activities and meetings.
- The committee maintained a dialogue with the Ministry of Economic Development, primarily in respect of the regulatory impact assessment procedure of legal acts related to insurance.
- The committee began to cooperate with the government on the issue of the national reinsurance company.
- The committee continued its cooperation with the State Duma Committee on Financial Markets. Vladimir Sukhinin, Deputy Chairman of the Committee, is a member of the Expert Council on Insurance Legislation (under the State Duma Committee on Financial Markets).

On 9 July 2015, the committee held an open event "Electronic insurance in Russia" with the participation of representatives of the Ministry of Finance, Central Bank, All-Russian Insurance Association and Russian Association of Motor Insurers, in which the participants discussed recent trends and developments in electronic insurance in Russia and exchanged experience and ideas.

On 22 December 2015, the committee held a business meeting "Corporate pension plans: how to act in the new environment", which updated the audience on pension reform and the pension market, and an overview of corporate pension programmes and solutions.

In 2015, the following topics and draft laws were discussed in the committee: the "cooling-off" period, the national reinsurance company (state reinsurer), electronic insurance, AML regulation of insurance activities, the new chart of accounts, the Bureau of Credit Histories and the price for an insurance history request, the limitation on investments in the assets of related parties (structural relations), the draft CBR regulation on the solvency margin for insurance companies, the draft law regarding specialised depositories, the draft law on self-regulated institutions (SROs) in financial markets, the draft law on improving the procedure for licensing insurance entities, the draft law on business reputation, and others. Furthermore, the committee initiated a discussion on the proposal for the AEB to become a member of the International Association for Insurance Law (AIDA) and to establish an AIDA Russian branch on the basis of the AEB.

The Working Group on Insurance Legislation chaired by Mariya Yurieva, MetLife, is part of the Insurance & Pensions Committee.

On 3 April 2015, the AEB Intellectual Property (IP) Committee and the AEB Taxation Committee held their Round Table "Tax related aspects of intellectual property transactions." The event provided a valuable platform for a discussion of the most important tax aspects of intellectual property transactions including SaaS and licensing relationships, VAT exemptions applicable to license contracts, the inclusion of license payments into the customs value of imported goods, transfer pricing, case law regarding tax disputes, free EULA taxation, and others.

On 5 June 2015, the AEB Intellectual Property Committee held its annual conference "Intellectual property rights: recent trends, court practices, problems and solutions" at the premises of the Delegation of the European Union to Russia. The IP annual conference serves as a platform for experts in intellectual property issues. It provides opportunities for its participants to learn about the most important issues in IPR protection through face-to-face interaction with representatives of state bodies, courts and leading legal companies, and it provides an important venue for discussion.

The event was moderated by Eugene Arievich, Chairman of the AEB Intellectual Property Committee, Partner, Baker & McKenzie. Sven-Olov Carlsson, Deputy Head of the Delegation of the European Union in the Russian Federation, welcomed the participants. Speakers from Russian state bodies (Federal Antimonopoly Service, ROSPATENT, Court for Intellectual Property Rights), and regional organisations (Eurasian Economic Commission, European Commission) addressed a variety of topics ranging from IPR protection within the Eurasian Economic Union, the exhaustion of trademark rights in Europe, and the expected intellectual property related changes in antimonopoly legislation. Experts from the AEB IP Committee spoke on recent trends in court practice involving the early termination of trademark legal protection; issues related to putting into circulation; commercial concession (franchise) agreements; the problems of intellectual property rights protection in the pharmaceutical industry, and the collision of the means of individualisation in the market.

On 1 October 2015, the AEB IP Committee met Sergey Matveev, Deputy Head of the Department for Science and Technology, the RF Ministry of Education and Science, to discuss the development of digital services for trademark owners. The committee prepared a presentation on the requirements of trademark owners for services concerning the principle of exhaustion of rights which was submitted to the Ministry.

On 19 October 2015, Eugene Arievich, Chairman of the Committee, had a meeting with representatives of the Embassy of South Korea in Russia to discuss the IPR system in Russia and issues of common interest.

On 1 December 2015, Anton Bankovskiy, Deputy Chairman of the Committee, met representatives of the Patent Office of Switzerland and the Swiss business community to discuss the IPR system in Russia and possible cooperation.

On 4 December 2015, the AEB Intellectual Property Committee took part in the Seminar on "Modernisation and alignment of appeal procedures for trademarks and designs in Russia and the EU". The seminar was organised by the Federal Service for Intellectual Property (ROSPATENT) and the Office for Harmonisation in the Internal Market (OHIM). The goal of the event was to discuss the draft study which is conducted under the Project "Modernisation of the IPR System of the Russian Federation".

In 2015, the IT & Telecom Committee, which is one of the most active in the AEB in organising open events for AEB members, covered a rather wide range of topics. The committee always tries to maintain a constant pulse with regard to new phenomena emerging not only strictly within the IT-Telecom industry but touching the boundary sectors as well.

This year the main lobbying efforts of the committee were focused on FL-242, which entered in force in September 2015. The Intercommittee Working Group on Personal Data created in July 2014 and led by Edgars Puzo, Chairman of the IT & Telecom Committee, continued its work and held several meetings, inviting representatives of governmental bodies (the RF Duma, Internet Ombudsman), big state Telecom companies (Rostelecom), analysts and professional associations (a fruitful meeting with APKIT was held in January).

The committee management and its members attended a number of major events organised by Roskomnadzor devoted to a better understanding and clarification of some disputable legal and technical aspects of the FL-242.

In 2015, the committee expertise was highly in demand. Edgars Puzo, Chairman of the Committee, participated in several meetings organised by a number of AEB Committees (Banking, Machine Building & Engineering) and EU Embassies (Finland, Switzerland), briefing their participants on the current situation in the IT & Telecom industry. Mr. Puzo was extremely active in the mass media, and he published several articles (Les Echos; Financial Times; Euronews; Ost-West Contact), gave interviews, participated in TV broadcasts (RBK TV, Levchenko's Angle), representing the views of the committee and more broadly of the European companies working in Russia in respect of current IT issues.

Another focus of 2015 was FL-188 on foreign software for state procurement. The committee, in cooperation with the AEB Machine Building & Engineering Committee, conveyed its concerns to the relevant ministries. The committee succeeded in establishing working relations with the RF Duma Committee for Information Police, IT and Communications regarding the adjustment and clarification of some legal points.

On 2 June 2015, the AEB Legal Committee held its business meeting "New changes to contract law provisions in the Civil Code: implications for AEB companies". The event was focused on the latest large-scale changes to the Russian Civil Code affecting various aspects of contractual work and claim management. The meeting participants, in-house lawyers and legal experts from consulting companies discussed practical aspects, challenges and opportunities which lawyers of AEB member companies might face after the amendments come into force. The meeting was moderated by Alexander Kozhukhov, Chairman of the AEB Legal Committee.

On 24 November 2015, the AEB hosted its annual briefing with the Head of Russia's Federal Antimonopoly Service, Igor Artemiev, "Federal Antimonopoly Service: New developments, plans and prospects". The briefing was organised by the AEB Legal Committee. As in previous years, Mr. Artemiev provided detailed answers to the questions put forward by the AEB member companies from different industries.

The topics included public procurement and related restrictions on foreign manufacturers; parallel imports; compulsory licensing; price regulation in the pharma market; antimonopoly compliance; antimonopoly regulation in the insurance industry; waste management and localisation (including special investment contracts). Mr. Artemiev also touched on the Code of Conduct for pharmaceutical producers, which is being drawn up by a special working group in the AEB Health & Pharmaceuticals Committee.

In July 2015, the AEB Board decided to establish an Arbitration Body in the Association of European Businesses. The Arbitration Body will serve as a dispute resolution mechanism for both AEB member and non-member companies willing to use the AEB Arbitration Body as an alternative to conventional litigation. The AEB believes that the Arbitration Body will provide a valuable avenue for companies and will be beneficial in terms of potential time and cost reduction. The AEB Legal Committee collected nominations from AEB companies to form a pool of arbitrators who possess the appropriate competence, expertise and qualifications. They will preside over disputes and take decisions on them.

In 2015, representatives from governmental and non-governmental organisations were invited to the regular committee meetings, namely:

• Yury Pilipenko, President of the Federal Chamber of Advocates, to discuss the current proposals for the reform of the legal profession.

The AEB Machine Building & Engineering Committee tries to keep a balance between topics and issues common to representatives of other "neighbour" branches such as automobile manufacturing, automotive components, construction equipment, technical regulations and standardisation, trying to act in synergy with other AEB Committees. In 2015, the committee continued to monitor the development of the Russian machine building market, and organised regular open events tackling the committee's most important issues such as localisation; import substitution; infrastructure; customs clearance; innovation; human resources; standardisation and certification. A traditional Round Table on trends in the Russian machine building sector in the RF was organised jointly with the AEB AMC, CVC & CEC Committees.

2015 was marked by the further strengthening of working relations with RZD. The process started by Valentin Gapanovich's briefing, followed by the participation of Philippe Pegorier, Chairman of the Committee, in the 10<sup>th</sup> International Rail Business Forum "1520 Strategic Partnership" (Sochi, 3–5 June 2015) and committee participation at EXPO 1520 and its 8<sup>th</sup> International Conference "Railway Engineering. Prospects, Technologies, Priorities", and in the International Business Forum: "Development of Russian-EU partner relations: joint projects outside of politics". A concord was signed by RZD & AEB summarising the results of the forum.

The Migration Committee actively lobbied on a wide range of topics related to migration legislation, such as the quantity of foreign employees working at branches and representative offices of international companies in Russia; migration cards for accompanying family members of expats working in Russia; the clarification of the application of administrative penalties and their consequences for expats in terms of migration law; the importance of passing Russian language exams for expats; the change of the payment terms of state duties at some FMS offices in Moscow, changes to law 115-FL with regards to payments made to Highly Qualified Specialists (HQS); the development of the law on using secondment agreements by legal entities, which are not employment agencies with the Ministry of Economic Development.

The committee also held several meetings with the FMS and Ministry of Economic Development officials in order to represent the AEB position on the issues mentioned above and the new online application system introduced by the Russian FMS.

On 8 April 2015, the AEB PR & Communications Committee held its open event "How does the investment climate influence business communications. What has changed?". The change in the investment climate in Russia and cooling in international relations leads to a change in the paradigm of the communications agenda. The current situation gives rise to the following questions discussed at the event: what do foreign companies and investors operating in Russia or planning to work with Russia need to take into account; how can communications be maintained in Russia under the new conditions; what is the threat of import substitution policies, what are the advantages for Russian companies and what can the state offer to foreign investors and companies; is it possible to speak the same language, the language of business; what are the trends for communications in the Russian and international media in relation to foreign and domestic companies operating in Russia; what are the benchmarks that you can trust in terms of political and economic sanctions for doing business in Russia.

On 26 June 2015, the committee held its open event "Social media: profit, loss or necessity?". The participants of the event exchanged views on the opportunities that social media can bring for business. For example, with the help of social media it is now easier than ever to directly target customers with marketing campaigns, promote new products or services, and personally interact with existing and potential customers. Social media gives you the opportunity to build brand awareness and customer loyalty. However, there are also dangers in participating in an online public forum. In this respect, the approaches that can be applied by companies to handling negative feedback were also discussed at the event.

#### **COMMITTEE ACTIVITIES, 2015**

In June 2012, the AEB Technical Regulation and Standardisation Task Force became the Product Conformity Assessment Committee (PCAC). The committee works in close cooperation with the Eurasian Economic Commission, the Committee for technical regulation, standardisation and conformity assessment of the Russian Union of Industrialists and Entrepreneurs (RSPP), the Delegation of the European Union to Russia, and the Directorate General for Enterprise and Industry of the European Commission. In 2015, the committee continued to focus on standardisation, accreditation, conformity assessment, market surveillance, and the harmonisation of industrial technical regulations of the Customs Union, representing the maximum interest for businesses with the corresponding European documents.

On 23 April 2015, the committee members held a meeting with certification bodies where they discussed problems related to production audits.

On 28 October 2015, the committee members held a meeting with representatives of the EU Project "Approximation of the EU and RF Technical Regulation and Standardisation Systems".

In 2015, the committee members worked in close cooperation with the Customs & Transport and Construction Equipment Committees on product labeling and several technical regulations.

The AEB Product Conformity Assessment Committee members will continue to act on the major problems identified in the field of technical regulation and standardisation, especially in the Customs Union.

The committee is composed of a number of companies specialising in various fields such as environmental protection, health & safety, security & risk management and compliance. The committee is divided into 3 Subcommittees – the Security & Compliance Subcommittee, the Environmental Subcommittee and the Health & Safety Subcommittee.

In 2015, all the subcommittees were active and organised 12 open events. The Security Subcommittee held 3 open events, the Environmental Subcommittee – 4 events, the Health & Safety Subcommittee – 4 events, and 1 event (dedicated to risk assessment and management in HSE) was organised on a cross-disciplinary basis.

The committee worked on increasing cross-committees activities and cooperation with representatives of the state authorities. In May 2015, the Security Subcommittee held a joint session with the HR Committee on "Security and legal aspects of recruitment and labour conflicts." In December 2015, the Environmental Subcommittee organised a meeting with Amirkhan Amirkhanov, Deputy Head of Rosprirodnadzor. Regular update meetings with Mikhail Begak, Deputy Chairman of the Technical Committee-113 "Best available techniques" established by Rosstandart were also introduced in order to provide committee member companies with up-to-date information and contribute to the development of the Best Available Technique Reference Documents (BREFs).

The committee wrote four lobbying letters on issues that are of particular importance for its members, including waste management at landfills, waste utilisation, the development of BREFs and employee medical checks.

Also, in order to respond to the evolving climate change agenda and assess its implications for European business in Russia in light of the COP-21 meeting in Paris, the committee participated in the organisation of an international Round Table "How to protect the environment from the impact of industry: the view of European businesses" together with the Russian Parliamentary European Club, with the participation of Ségolène Royal, the Minister of Ecology, Sustainable Development and Energy of the Republic of France as a keynote speaker.

In Q4 2015, the committee published its first ever edition of the Business Quarterly magazine dedicated to safety, health, environmental and security issues.

Overall, in 2015, the committee made significant progress towards achieving its goals and objectives, which were reset in order to meet the needs of its members.

# All-Russian Seed-trial Day and Memorandum of Understanding with the State Commission for Selection Achievements Test and Protection

The AEB delegation consisting of Seed Committee company members, and chaired by Ruslan Kokarev, AEB COO, and V. Druzhina, Chairman of the Committee, participated in the All-Russian Seed-trial Day in the Tambov region on 1–2 July. The second day was dedicated to a dialogue between the authorities and business representatives on key issues related to improving seed breeding procedures in Russia. As a marker of serious intentions for further cooperation a memorandum of understanding was signed between the AEB and the State Commission for Selection Achievements Test and Protection. The discussion continued at the Round Table at the 17<sup>th</sup> Russian Agricultural Exhibition Golden Autumn 2015 on 9 October (Moscow).

#### Contribution of international companies to Russian agriculture

This year companies elected to put more effort into creating a solid evidence basis for the work of international companies in Russian agriculture. To implement it a Communication and Information Support Intercommittee Working Group was created. This Working Group initiated a market survey aimed at determining the contribution of international Crop Protection and Seed producers to the development of Russian agriculture. It was based on large-scale interviews of farmers from more than 400 farms and in-depth interviews with the heads of big agroholdings and experts (industry union directors and scientists).

More than a half of the respondents recognised the contribution of international companies in implementing innovative technologies: 48% in the newest selection developments; 42% in the development of new active substances. This and other key results are presented in the Position Paper that will be sent to the authorities and mass media in the beginning of 2016.

The survey results complemented with the analysis of educational programmes organised by the companies were presented at:

- Agribusiness Committee Open Event: "The Role of European business in the modernisation and development of the Russian agricultural sector", 5 October;
- Plenary Session of the YUGAGRO Exhibition, 24 November in Krasnodar.

## **COMMITTEE ACTIVITIES, 2015**

On 29 May 2015, the committee organised the event "Anti-crisis measures for SMEs: government and business initiatives." The impact of the economic crisis on the small and medium business sector has been significant. SMEs are now considered the most sensitive sector and the most impacted by the worsening economic climate. The event provided an overview of anti-crisis measures envisaged by the Russian authorities at the federal and regional levels: the Ministry of Economic Development of the Russian Federation and the Government of Moscow. The speakers shared with other participants their recommendations on how to gain access to specific federal and regional anti-crisis programmes, and also how to overcome the difficulties that are arising for small and medium enterprises (SMEs) in the current financial environment. The event provided a platform for discussing issues related to the impact of localisation and import substi-

tution on SMEs, the opportunities to streamline HRP operations and increase the effectiveness of accounting systems, and the introduction of corporate culture as a way to increase profits and reduce costs.

On 10 December 2015, the Small & Medium-Sized Enterprises Committee held its open event "AEB business dating". The event was aimed at facilitating the efforts by small and medium-sized companies to establish contacts with international companies operating in Russia. The participants of the event were given the opportunity to have individual face-to-face meetings to introduce their solutions and services to the following companies: ALD Automotive Russia/Rosbank; Allianz; CEB SHL Talent Measurement Solutions (Business Psychologists Ltd); ENGIE (known as GDF SUEZ); FENICE RUS; FLSmidth Rus; Messe Frankfurt RUS; METRO GROUP; ROCA; TMF Group; YIT. The international companies were represented by the executives responsible for management, HR related processes, procurement, communications, logistics, events organisation, etc.

#### **COMMITTEE ACTIVITIES, 2015**

On 13 November 2013, the Tire Producers Working Group was transformed into a separate Tire Producers Committee. Taking into account that the technical regulation of the Customs Union "On the Safety of Wheeled Vehicles" came into force on 1 January 2015, the AEB Tire Producers Committee believes that it is necessary to facilitate the process of the entry into force of the new requirements of the Technical Regulations and continue to work on the harmonisation of the technical requirements contained in the various legislative acts of the Russian Federation: the Highway Code, the Administrative Code, the law on "Technical Inspection" from 2011, etc., and to continue its work on additional amendments to the Technical Regulation of the Customs Union on the obligatory use of winter tires. Tire manufacturers propose to install winter tires on the drive axle for M2, M3 and N2, N3 vehicles, starting from 1 January 2016.

One of the key issues that the committee is currently working on is the recycling tax. The new bill "On waste from production and consumption" provides variability for producers and importers in fulfilling their recycling obligations for a product that has lost its consumer qualities. It provides two options: 1) the payment of an environmental fee to the budget and 2) independent, and possibly in an association of producers and importers. Neither of these options makes it possible to categorise producer costs as production cost or account for them as expenses to reduce the tax base for income tax. As a result, these expenses will have to be paid from net profit both for producers and importers. Right now the working group is actively looking into the possibility of taking into account expenses to reduce income tax, and if necessary, drafting amendments to the Tax Code.

On 6 February 2015, the AEB Working Group on Modernisation & Innovations organised an open event: Presentation of the Russian Venture Company (RVC): "Opportunities and mechanisms for cooperation." The RVC was represented by Gulnara Bikkulova, Technology Capital and Markets Access Department Director, member of the board of the Russian Venture Company. Mrs. Bikkulova provided a comprehensive overview of the work of the RVC and highlighted the areas in which the AEB member companies and RVC could potentially cooperate. The Russian Venture Company (RVC) is a government fund and a development institute of the Russian Federation, one of Russia's key tools in building its own national innovation system.

On 13 February 2015, the AEB held a briefing by Andrey Nikitin, Director General of the Agency for Strategic Initiatives, at the AEB Conference Room. The briefing was organised by the AEB Working Group on Modernisation and Innovations and moderated by Ruslan Kokarev, AEB COO, and Michael Akim, Chairperson of the AEB Working Group on Modernisation and Innovations, Member of the AEB Board, Vice-President, ABB Russia. The event provided the AEB members with key information on the ASI projects to improve the business climate in the Russian regions, the opportunity to share concerns and ideas regarding possible involvement in the ASI instruments. The meeting participants addressed Mr. Nikitin on several important issues concerning the construction and retail sectors. The AEB and ASI intend to strengthen their cooperation on a practical basis. The Agency for Strategic Initiatives to Promote New Projects was created in 2011 to coordinate the processes of improving the national business climate, supporting business and reforming education models. This initiative belongs to Vladimir Putin who remains the chairman of the supervisory board of the agency.

Innoprom 2015, Ekaterinburg: on 9 July, the AEB organised the Round Table "European technologies for productivity gain in industry." The topics discussed included the problem of rapidly growing expenses, labour costs, "Dutch disease" and priorities in selecting technologies that boost labour productivity. The Chairman of the Working Group on Modernisation & Innovations, Member of the Board of the Association of European Businesses, and Vice President of ABB Russia Michael Akim moderated the event. The speakers included: Vasily Osmakov, Director of the Strategic Development Department of the Ministry of Trade & Industry of the RF, Dietrich Moeller, the President of Siemens Russia and Central Asia, Alexey Komissarov, the Director of the Industry Development Fund, Julien Thöni, the Counsellor and Head of the Economy, Finance and Science Division, Embassy of Switzerland in the RF, and others.

Innoprom 2015, Ekaterinburg: on 10 July, the AEB organised the Round Table "Boosting labour productivity on construction sites and in infrastructure projects: the European business experience." The speakers analysed the opportunities to increase productivity in these sectors and looked at the application of European technologies and practices in order to achieve the highest global standards for industrial productivity. Michael Akim, Chairman of the Working Group on Modernisation & Innovations, also moderated the meeting. The speakers included: Sergey Bidonko, Minister of Construction and Infrastructure Development of the Sverdlovsk Region, Natalya Vikhrova, Corporative Director of WordSkills Russia at the Agency for Strategic Initiatives, Artak Makaryan, Business Development and Investment Director, YIT, and others.

On 2 December 2015, the AEB held the Round Table "How to continue EU-Russia innovative cooperation in view of the current challenges and priorities" at the III National Exhibition-Forum VUZPROMEXPO 2015. The session was aimed at identifying key opportunities and mechanisms for expanding the number of ways in which Russia and Europe can cooperate in science, education and industry. The Round Table was organised by the AEB Working Group on Modernisation & Innovations, and was moderated by Michael Akim, Chairman of the AEB Working Group on Modernisation & Innovations. Ruslan Kokarev, AEB COO, delivered a welcome speech to the participants. Pierre Helg, H.E. Ambassador of Switzerland, shared the Swiss experience of conducting joint science and technology programmes. The speakers were: Sergey Salikhov, Director of the Department for Science and Technology of the RF Ministry of Education and Science, Artem Shadrin, Director of the Department of Social Development and Innovations of the RF Ministry of Economic Development, Richard Burger, Research & Innovation Counsellor, Head - Science & Technology and other EU Policies Section of the Delegation of the European Union to the Russian Federation, Igor Agamirzyan, General Director of the Russian Venture Company, and Tatiana Sazonova, Head of Intellectual Property & Standards, PHILIPS LLC (Russia, Ukraine, Belarus, Caucasus and Central Asia).

The VUZPROMEXPO forum was organised by RF Ministry of Education and Science jointly with RF Ministry of Industry and Trade. The event was aimed at demonstrating modern and scientific projects in order to modernise Russian industry, and successful examples of close cooperation between European businesses and Russian universities. The main topics that were covered at the more than 100 events at VUZPROMEXPO 2015 were Russian import substitution policies and innovative development programmes, engineering work and industrial design, advanced production technologies, technology platforms, technological forecasting, and the public-private partnership model for implementing major projects. A special focal point in the programme was on innovative cooperation between universities and companies. Following its motto "From idea – to reality", the forum served as a link between science and industry, developers and investors.

On 16 December 2015, the AEB Working Group on Modernisation & Innovations coorganised the 2<sup>nd</sup> meeting of the R&D Club of the French Embassy in Russia. The meeting took place at the AEB Conference Room. Aage V. Nielsen, Deputy Chairman of the Working Group on Modernisation & Innovations, made a welcome speech and introduced the work of the AEB Working Group on Modernisation & Innovations. The keynote speaker was Richard Burger, Counsellor for Research and Innovation at the Permanent Representation of the EU in Russia, who spoke on "Horizon 2020: opportunities for cooperation with Russia." The other speakers were Thierry Cellerin, President of French Tech Russia – a governmental initiative for innovative French start-ups and companies abroad, Sergey Krzhanovsky, Technopark Skolkovo, who presented the annual meeting of the International Association of Science Parks (IASP). The R&D Club was set up on the initiative of the French Embassy in Russia for French companies and groups in Russia working in R&D and innovation. The club's objectives are to share best practices, increase synergy between groups, and to assist French companies and groups working in R&D and innovation.


