

9. Oblige:

9.1. Citizens to keep a distance from other citizens of at least 1.5 meters (social distancing), including in public places and public transport, except for provision of services for transportation of passengers and luggage by passenger taxis.

9.2. Authorities, organizations, and individual entrepreneurs, as well as other persons whose activities are related to joint presence of citizens, to ensure that citizens (including employees) observe social distancing, including by applying special markings and establishing a special regime for access to and being in buildings and structures (premises inside of them), on their territory (including the adjacent territory).

9.3. Citizens not to leave their place of residence (stay), except in cases of seeking emergency (urgent) medical care and cases of other direct threats to life and health, moving to (from) the location of activities (including their work) that are not suspended in accordance herewith, performance of activities related to movement within the territory of the city of Moscow, if such movement is directly related to performance of activities not suspended in accordance with this decree (including the provision of transport services and delivery services), as well as moving to the nearest location of purchase of goods, works, services the sale of which is not limited in accordance with this decree, walking pets at a distance of not more than 100 meters from their residence (stay), and disposal of garbage at the nearest location for garbage disposal.

Restrictions established by this clause do not apply to medical care, activities of law enforcement agencies, civil defense and emergency agencies and organizations subordinate to them, supervisory bodies in the field of consumer protection and human welfare, and other bodies related to activities directly aimed at protecting the life, health, and other rights and freedoms of citizens, including countering crime, protecting public order, property and ensuring public safety.

Restrictions set forth in this clause also do not apply to citizens if they possess special passes issued in accordance with the procedure established by the

Government of Moscow.

10.6. Organize the provision of free antiviral drugs according to the medication list approved by the Department of Health of Moscow to citizens carrying the new coronavirus infection (2019-nCoV), including on an outpatient basis, and citizens involved in implementation of the measures to prevent the spread of the new coronavirus infection (2019-nCoV) in the city of Moscow, as determined by the medical organizations of the Moscow government healthcare system.

17.3. The validity period of paid travel tickets of the State Unitary Enterprise of Moscow "Moscow Metro named after V. I. Lenin, Recipient of the Order of Lenin and the Order of the Red Banner of Labour" (hereinafter referred to as "Moscow Metro") and the State Unitary Enterprise of Moscow "Mosgortrans" (hereinafter referred to as "Mosgortrans") for 60 trips, without a trip limit for 30 days, 90 days, 365 days that are not used for travel and not expired in the period from 30 March through 3 April 2020, shall be extended by 5 calendar days from the day following the date of expiry of the validity period of such tickets, if the passengers apply to the ticket office of Moscow Metro or Mosgortrans no earlier than 6 April 2020.

17.4. The validity period of paid travel tickets of Moscow Metro and Mosgortrans for 60 trips, without a travel limit for 30 days, 90 days, 365 days that are not used for travel and expired in the period from 30 March through 3 April 2020 (inclusive), shall be extended by 5 calendar days from the day the passengers apply to the ticket office of Moscow Metro or Mosgortrans, no earlier than 6 April 2020.

17.5. The validity period of paid reduced-rate tickets of Moscow Metro and Mosgortrans for students without a limit of trips for a month and three months, suspended in accordance with clause 7.3 hereof, shall be renewed after termination of the high-alert regime when the passengers apply to the ticket office of Moscow Metro or Mosgortrans for the period up to the end of the calendar month following the calendar month when the ticket expires.

18. Citizens recognized as unemployed according to law (with the exception of citizens dismissed for misconduct or other wrongful acts as provided by the law of the Russian Federation, citizens having the length of employment and other activities recognized in accordance with the law of the Russian Federation 1032-I dated 19 April 1991 "On population employment in the Russian Federation" as employment of citizens, from the beginning of 2020 of less than 60 calendar days) to receive regional compensatory payment for a lost job (hereinafter referred to as regional compensation) at the expense of the budget of the city of Moscow in the period from 1 April 2020 to 30 September 2020, in addition to payments received as part of additional financial support for unemployed citizens.

For unemployed citizens, regional compensation is established in such an amount that the total amount of payments, including any unemployment benefits (stipends), payments under additional material support for unemployed citizens, and regional compensation is RUB 19,500.

Regional compensation for unemployed citizens registered as of 31 March 2020 with the employment service of the city of Moscow is established without any application.

Regional compensation for unemployed citizens who receive such status during the period of the declared regime of self-isolation of the population, or within 30 calendar days from the date of termination thereof, is established from the date of their dismissal or termination of activities recognized in accordance with the law of the Russian Federation 1032-I dated 19 April 1991 "On population employment in the Russian Federation", as employment of citizens regardless of the fact that unemployment benefits are granted during said period, but no earlier than 1 April 2020.

Regional compensation shall not be taken into account when calculating the amount of material support (income, combined income) of a citizen (family) when determining the right to receive other social support measures, including targeted social assistance, state social assistance, state allowances, compensations, payments in addition to pensions, other social payments, social services, and

subsidies for housing and utilities.

19. Citizens recognized as unemployed in accordance with the law, sent by the employment service of Moscow to vocational training and additional professional education and not transferred to distance learning during the high-alert period, to continue to receive stipends at the expense of the budget of the city of Moscow until termination thereof, and to receive regional compensation in accordance with clause 18 hereof.

20. Citizens recognized as unemployed in accordance with the law, sent by the employment service of Moscow to vocational training and additional professional education, and transferred to distance learning due to the high-alert regime, to receive regional compensation in accordance with clause 18 hereof.

21. Citizens who complete vocational training or additional professional education as assigned by the employment service of the city of Moscow after 5 March 2020 and are not employed, who apply to the employment service of the city of Moscow to register as an unemployed person by submitting an application via the website czn.mos.ru or by phone +7 (495) 705-75-75 and recognized as unemployed in accordance with the law, are to receive regional compensation in accordance with clause 18 hereof.

23. The procedure for monitoring proper compliance with the regulations and restrictions established hereby, as well as the procedure for ensuring proper compliance with such regulations and restrictions, including measures to prevent violations of the relevant regulations and restrictions, shall be established by the Government of Moscow.
