Intermark is pleased to offer you the opportunity **to obtain a foreign bank card** in Moscow. To **receive the card** you do not have to go anywhere. Intermark specialists will **deliver** you Visa/MasterCard, which you can use for **shopping on foreign sites** and for subscriptions payments. You will also easily **make cashless payments** or **withdraw currency from ATMs** while traveling abroad.

Let us tell you in more details how to obtain a foreign bank card **in person** or **remotely**, in other words, without your presence in the country of issue.

1. **Kazakhstan**

Kazakhstan – multifunctional:

1. Issuance starts from 8 weeks;
2. Documents and deposit to the bank are required to issue a card.

About the card from a Kazakh bank:

- MasterCard – multicurrency \$ / € / ₸ / ₸;
- Required deposit (₸ 15 000, approx ₺ 2 500) is returned when closing the account, free card service;
- Replenishment directly or via MIR system and via Swift;
- Mobile app available in Russian.

2.1. **Kyrgyzstan**

Kyrgyzstan – fast and low-cost:

1. Issuance takes 10-15 calendar days;
2. Notarial power of attorney required.

About the card from a Kyrgyz bank:

- Visa – Gold or Platinum level, bank account in Rubles and Soms, currency – Dollars;
- More than 10 ways of replenishment in Rubles;
- Swift available only in Rubles, it is impossible to deposit or withdraw currency;
- Mobile app in Russian.

2.2. **Kyrgyzstan**

Kyrgyzstan – alternative:

1. Issuance takes 15-20 calendar days;
2. Notarial power of attorney required.

About the card from a Kyrgyz bank:

- Visa – Gold / Platinum / Infinite levels, bank account in Rubles, Dollars, Euros and Soms;
- More than 10 ways of replenishment in Rubles;
- Swift available in every currency, low bank fees from 0,35%, minimum \$20;
- Mobile app in Russian

3. **Armenia**

Armenia – profitable deposits:

1. Issuance takes 6 weeks;
2. Bank appoints and conducts online interview; documents signed through Zoom or WhatsApp.

About the card from Armenian bank:

- MasterCard: € / \$;
- Replenishment in Rubles directly via Swift; outgoing Swift is temporarily restricted, available only in Rubles; card-to-card transfers in currency;
- Mobile app in Russian.

Obtaining a foreign bank card in person is available in Turkey and Georgia.

- ✓ **Turkey**
- 3 bank options;
- Various Turkish cities;
- Issuance takes 1 calendar day;
- The package of documents is prepared in advance, paid separately.

About the card from Turkish bank:

- Multicurrency - MasterCard \ Maestro \ Visa: \$ \ € \ £ \ ₺

- ✓ **Georgia**
- Issuance takes 10-15 calendar days;
- Pre-opening of the account (client's KYC) is done in advance.

About the card from Georgian bank:

- Multicurrency - VISA: \$ \ € \ £ \ ₾.
