DEAR READERS,

The AEB is the largest foreign business association in Russia, representing the interests of about 500 leading European and international companies. Since 1995, the Association has been gradually expanding the scope of its activities through the substantial work of Committees and Working Groups.

In 2018 the AEB focused on dealing with such issues as: defending the interests of investors in a fast-moving environment amid sanctions, parallel imports, localisation, track & trace system, customs and transport, migration, taxation, waste management, technical regulation, conformity market surveillance, and a variety of other topics suggested by member companies.

The AEB highly appreciates its working relations with the media. We have broad coverage of the most significant AEB events by the federal and regional information agencies. AEB activities are covered by both Russian and international press.

In 2018 we proceeded with production of publications. The "Business Quarterly" magazines explored such topics as: digitalization; a new customs regulatory environment; safety, health, environment and security; legal and intellectual property issues. As always, magazines were broadly distributed at Moscow business centres, hotels, restaurants, airports and embassies, at AEB regional branches in St. Petersburg and Krasnodar, as well as at all AEB external and internal events. Likewise, the "Real Estate Monitors", the "How to invest in Russia" guide, the "European Business in Russia: Position Paper 2019", the "Annual Report 2017", and the "Report on AEB Lobbying Activities" were released.

We would like to express our genuine gratitude to the members of the AEB Board, the Council of National Representation, the Auditing Commission and Chairpersons of the Committees, Subcommittees and Working Groups for their ongoing support and trust, for valuable inputs made to promote the interests of AEB member companies, and for efforts invested into enhancing economic relations between Russia, the European Union and the Eurasian Economic Union.

This Annual Report will summarise the activities the AEB managed to implement in 2018. In particular, we had a number of top-level briefings, meetings and presentations. We also organised numerous open events, conferences, round tables and receptions. AEB representatives took part in major economic forums held in Russia.

We hope that the AEB accomplishments will help to create more favourable conditions for doing business in Russia and reveal potential of member companies.

THE ASSOCIATION OF EUROPEAN BUSINESSES (AEB)

- Was created in 1995 by a number of companies operating on the Russian market, Ambassadors of EU member countries and the Head of the European Commission's Representative Office in the Russian Federation.
- Is the main representation of foreign investors in Russia, from small-size newcomers to major multinational corporations. The Association also includes a number of key Russian, American, Japanese and other companies.
- Is a unique organisation developing cooperation between Russian and European business circles. The AEB mission is to improve the investment climate in Russia in the interests of its member companies, and promote a favourable image of Russia abroad to improve business development conditions inside the country and attract foreign investors.
- Annually organises 100+ conferences, seminars, briefings and roundtable discussions dedicated to vital aspects of running a business in Russia. Regular speakers at the Association's dialogue with European business include Ministers of the Russian Government, Heads of Administrations of the Russian regions, official representatives of international financial organisations, key economic agencies and organisations, independent experts and leading European and Russian businessmen.

Committees, Subcommittees and Working Groups. Committees and Working Groups are the backbone of the AEB. Currently, there are over 60 Committees, Subcommittees and Working Groups representing companies from various industries.

Lobbying. The Association promotes its members' interests by closely cooperating with Russian, EU and EAEU authorities, and holding regular consultations with relevant officials. The European Commission and the Eurasian Economic Commission have regularly consulted with the Association with regard to financial and commercial relations with the Russian Federation. The AEB lobbying is based on the maximum transparency, high professionalism and a mechanism of reacting to new challenges which has been adjusted for many years.

Consulting. The Association engages European and Russian experts to provide consulting services to Russian, European and Eurasian officials and member companies on legal, financial and economic matters. In particular, practical support is offered in safe and transparent investment, issues of human resources and corporate management.

The AEB has two regional branches – in St. Petersburg and Krasnodar.

Press releases

In 2018, the AEB Marketing, PR and Communications Department issued a number of press releases, including monthly press releases related to sales of new passenger cars and light commercial vehicles in Russia; quarterly press releases on sales of new construction equipment; the results of the annual AEB-GfK Rus survey "Strategies and prospects for European companies in Russia"; messages about AEB lobbying activities, initiatives and briefings.

In 2018, the AEB was mentioned in the media 14,673 times (of which 8,984 quotes were in the federal press; 4,410 - in the regional sources, and 1,279 - in the foreign media).¹

AEB Corporate Social Responsibility

The AEB supported the Tagansky Children's Fund in 2018 through a mutually beneficial cooperation.

Online activities

In 2018, the AEB Facebook page developed as a powerful communications tool for our members, partners and a wider audience. All recent updates on the AEB most important events are posted on a regular basis. Since the beginning of 2018, the number of permanent followers of the AEB Facebook page increased by more than 300 individuals; the average publications reach is 1,388 views per post.

In October 2018, the AEB launched its account in Instagram. Since that time, the account has rapidly gained numerous subscribers.

The AEB Twitter account was revitalised last year.

Likewise, we kept producing numerous online surveys regarding the outcomes of the implemented activities and the level of satisfaction among member companies.

Publications

The AEB continued to produce its official "Business Quarterly" magazine with a print run of 16,000 copies. Each issue covers a selected topic related to the most relevant challenges which businesses have to face while operating on the Russian market. The magazine contains AEB updates, brief description of new members, and information provided by member companies on their most recent developments and appointments.

Four quarterly "Real Estate Monitors" were released last year (two in a print form and two as online versions). The publications review capital, retail, office, warehouse, hospitality and housing markets in Moscow and St. Petersburg, and are broadly illustrated with detailed graphs and tables.

The "How to invest in Russia" annual guide covers business, financial, legal, corporate, environment and other aspects of investments. It also provides an insight into investments by regions and industries as well as into opportunities for production localisation in Russia. The magazine was published in November 2018.

Traditionally, the Position Paper came off the press in late 2018. The edition accumulates specific issues and clear recommendations elaborated by the AEB Committees and Working Groups with regard to the most acute issues which businesses have to encounter in a rapidly changing environment.

COMMITTEE ACTIVITIES, 2018

Localisation remained the main lobbying issue of the Agribusiness Committee in Russia from 2012 till 2018. The Committee addressed this issue in its letters to A. Gordeev, Deputy Chairman of the Government responsible for the agricultural complex, and to D. Kozak, Deputy Chairman of the Government in charge of industrial issues.

The other target issues for lobbying are application of emissions' stages for tractors under Technical Regulation 031/2012, introduction and implementation of electronic passports for self-propelled vehicles, as well as disposal fee.

On 24 April 2018, Committee's representatives met with A. Kuleshov, Deputy Director of Rosstandart, with regard to Technical Regulation for tractors TR 031/2012, to discuss compliance under the technical regulation for tractors.

Since there was a need to bring this discussion to a higher level, the Committee organised with support of the German VDMA Agricultural Machinery a joint meeting with A. Gotovskiy, Deputy Director of the Department for agricultural complex, Eurasian Economic Commission, and representatives of the Technical Regulation Department, Eurasian Economic Commission, on emissions' stages for tractors under TR 031/2012 on 4 June 2018.

Tightened criteria of Decree 719 led to tightening conditions for allocation of federal and regional subsidies to Committee's companies, which resulted in issuance of Decrees No. 24 and No. 125 of the Ministry of Agriculture. The Committee initiated a meeting with M. Medvedkov, Director of the Department for trade negotiations at the Ministry of Economic Development, to discuss the impact of these documents on the agricultural sector and modernisation of agricultural machinery park on 15 June 2018.

COMMITTEE ACTIVITIES, 2018

In 2018, the AEB Airline Committee continued lobbying efforts to eliminate discrimination of foreign air carriers which have to pay higher amount of airport charges for using airport infrastructure in comparison with the local air carriers. For this purpose, the Committee submitted letters to officials of the four main airports of the country stressing the importance to equalise tariffs for foreign and Russian air carriers to pay for airport services.

Another important issue was VAT exemption for international air carriers, since this violates several international agreements of the aviation industry. A letter to M. Akimov, Deputy Chairman of the Government in charge of digitalization of the economy, with a copy to E. Dietrich, Minister of Transport, and M. Mishustin, Head of the Federal Tax Service, were sent.

Attraction of new Committee members is also an important topic of the Committee's efforts.

COMMITTEE ACTIVITIES, 2018

The year 2018 was the 21st year of AMC operations within the AEB.

For the 12th year the Committee continued running for its members an online sales data exchange system, which remained almost the only up-to-date and reliable source of statistics of sales of passenger cars (PC) and light commercial vehicles (LCV) in Russia. Following a well-established tradition, results of the year 2017 were opened to the media at the AMC Annual Press Conference. But unlike the previous years, for the first time the Committee refused to announce the market forecast for 2018 due to absence of clarity with the disposal fee rates at the beginning of the year. That was a strong signal of the industry which looks forward to clear and predictable market conditions. The press conference provided the press with an opportunity to interact with heads of the automobile companies, with regard to very important issues related to the automotive industry.

In April 2018, the AEB and ROAD concluded the Memorandum of Understanding which aims at creating fair, open and transparent rules of competition on the Russian new cars sales market. The MoU is the first industrial agreement. The MoU combines good practices of car manufacturers/distributors and official dealerships in a single document. The Good

Practices is a set of minimum standards that respective participants of the Russian new cars sale market should comply with, wherein the Good Practices do not exclude or replace legislative regulation, but only supplement it in those parts that are not regulated in detail. By the end of the year 15 members (more than 50%) joined the document.

One of the main issues on the AMC agenda in 2018 was a mandatory introduction of the digital passports of the wheeled vehicles (EPTS). Apart from being official active members of the EEC Working Group on introduction of digital passports of wheeled vehicles, the AMC organised for its members numerous meetings with participation of representatives of AO "Electronniy Passport", Ministry of Industry and Trade, EEC and other involved parties. Largely due to the AMC efforts, the date of the mandatory EPTS introduction was postponed to November 2019. The Committee will continue monitoring the development of the EPTS systems in close cooperation with the responsible state bodies and AO "Electronniy Passport" and will act in the interest of its members.

Technical Regulations of the Customs Union, TR CU 018/2011, "On the safety of wheeled vehicles" which entered into force on 01.01.2015 remained on the agenda of the Committee throughout the year 2018. The Committee closely worked with the government authorities over the improvement of motor vehicles certification system. In particular, the Committee actively participated in round table discussions with Rosstandart, Minpromtorg, and Certification bodies addressing all important issues of the practical application of the TR CU 018/2011, "On the safety of wheeled vehicles". Replacement of the national standards on ERA-GLONASS by the interstate standards will remain on the agenda of the Committee along with the changes in the roll-over GOST.

In 2018 the AMC worked at deepening cooperation with the Russian Union of Motor Insurers (RSA) in order to make the process of compensation under OSAGO more transparent and repaired cars safer for the customers. Representatives of the Committee also became members of the dedicated Working Group at the Central Bank. The work to improve the Central Bank Methodology for car repairs will be continued in 2019.

Regulations for labelling of goods (trace and track system introduction) attracted attention of the members due to potential mandatory labelling of spare parts, components, accessories, etc. This topic will be in focus of the AMC activities in 2019.

Special Committee efforts are targeted at establishing the market of electric vehicles and innovative driving technologies. The AMC established good contacts to NTI Avtonet and became a member of the Avtonet Working Group on the legislation for innovative transport development.

The new cars sales market demonstrated strong growth in 2018. The VAT increase by 2% from 1 January 2019 might change the trend and slow down the market. The AMC will continue informing about it through press-releases on a monthly basis. The car sales statistics provided by the AMC is widely used by all automotive and business media in Russia and abroad. Press coverage of issues addressed by the AMC and its activities in general further increased in 2018.

Throughout the year the Committee representatives actively participated in other important events, at which they spoke on behalf of the AMC, such as, "Rosavtodealer-2018", the 102nd International Scientific-Technical Conference of the Association of Automobile Engineers "Technical Regulation of the Automotive Vehicles" and others.

AMC nominated representatives to various industry related committees and working groups created by the Ministry of Industry and Trade, the Federal Agency on Technical Regulating and Metrology (Rosstandart), the Federal Agency for Accreditation (Rosaccreditation), TK-056 and others.

An AMC representative participates in the work of the UN EC Working Group on development of the UN rules on a permanent basis.

The Committee continued strengthening its contacts with the national and international automotive associations: European Automobile Manufacturers Association (ACEA), Association of Russian Automakers (OAR), International Organisation of Motor Vehicle Manufacturers (OICA), Association "Russian Automobile Dealers" (ROAD), German Association of the Automotive Industry (VDA), as well as with the local authorities and industry officials.

Development strategy

On 18 January 2016, the President of Russia ordered the Government to elaborate a development strategy for the automotive and auto parts industry up to 2025. The Automotive Industry Development Strategy was approved by Government Order of April 28, 2018 No. 831-r; the document is mostly addressed to vehicles manufacturers.

The key idea of the Automotive Industry Development Strategy is to renovate Russia's fleet of vehicles and to develop advanced technologies, with a particular focus on the need to develop the manufacturing of automotive components. Among the complex challenges are: small share of the exports, poor development rates of autocomponents sector, and lagging behind the global technological trends.

It should be additionally noted that a planning horizon up to 2025 is not strategic for the industry. The projects for which preparation started in 2018 (before the strategy was approved) shall be launched into serial production by early 2020 only, and by 2025 they shall still be in production. Nevertheless, the existence of this strategic document is positively evaluated by all key players.

State regulation of the industry: Government Decree 719-PP

The effective period of industrial assembly agreements is limited by 2020, while agreements of some manufacturers expired by the end of 2018. Instead a new mechanism of state support is being developed. It is based on draft amendments to the Decree of the Government of the Russian Federation dated July 17, 2015 No. 719 "On the criteria for classifying industrial products as industrial products without analogues manufactured in the Russian Federation". At the present the Draft is under discussion.

The Committee gives a positive overall assessment of the initiatives for the development and support of the automotive industry; however, the Draft obviously requires additional work. In its current wording, the objectives established by the automotive industry development strategy are not plain to be achieved. Further development of the industry is impossible without targeted measures for the development and support of autocomponents manufacturers, the priorities of which shall be determined in the Autocomponents Industry Development Strategy. As for the Autocomponents Industry Development Strategy, the draft is ready, but the final version has not been approved yet.

Automotive components industrial assembly regime

From 1 July 2018, under the obligations to the WTO, Russia lost the ability to further apply the "industrial assembly" regime in its current form. Thus, Russia was supposed to take appropriate steps from this date to introduce amendments to the EAEU Common Customs Tariff. The Ministry of Industry and Trade of the Russian Federation, in line with Clause 2 of Federal Law No. 190 of July 23, 2013, "On certain measures of state support for individual categories of manufacturers of motor vehicles and parts", developed a draft decree to provide the subsidies to automotive companies to compensate their expenses associated with the increase of duty rates. This draft passed public discussion and interdepartmental approval, and was approved by the Government of the Russian Federation by Decree dated 26.10.2018 No. 1278 to compensate the expenses related to purchases of components in 2018.

Export of automotive components

In 2017, the Russian automotive market started to grow after a four-year decline. According to the 2018 forecasts, the market will grow by 12-14%. Nonetheless, market still fails to meet investors' expectations, and development of export supplies remains a key factor for automotive components manufacturers who have invested in local production capacities, in order to increase the utilisation of these capacities and to maintain the operations of the enterprises.

COMMITTEE ACTIVITIES, 2018

In 2018, the Committee continued cooperation with its key partners:

- The Committee continued to collaborate with the regulator the Central Bank of the Russian Federation (CBR). The Committee sent a number of letters with comments and proposals on banking regulation and requests for clarifications to the Central Bank (CRS implementation in Russia, cancellation of notary power of attorney, biometric data, the reporting programme Kliko, etc.). In June 2018, the Committee held a meeting with Elvira Nabiullina, Governor of the Central Bank of Russia, to discuss issues related to banking regulation, latest U.S. sanctions, the draft law introducing criminal responsibility for complying to sanctions of foreign states and to agree on possible areas of cooperation in the future. In August 2018, the Committee took part in the meeting organised by the Central Bank and chaired by Dmitry Tulin, First Deputy Governor of the Central Bank, regarding the draft CBR Regulation amending mandatory banking standards (N6).
- Also, the Committee communicated on issues related to banking regulation with the Government, Ministry of Finance, as well as to the Federal Notary Chamber. In July 2018, the Committee held the meeting with representatives of the Federal Notary Chamber and the Central Bank regarding cancellation of notary power of attorney.

To cover specific issues, in 2018 two Working Groups were established within the Committee:

• Working Group on Legal Issues (chaired by Vyacheslav Norenko, HSBC Bank (RR) OOO);

• Working Group on Anti-Money Laundering (AML), Compliance and Internal Control Issues (chaired by Nataliya Velikanskaya, Banca Intesa).

Furthermore, the group of CEO-level representatives of the Committee's member banks held 14 informal meetings and consultations to discuss developments and activities in the banking industry, including a meeting with Francesca Caselli, Economist in the World Economic Studies Division of the Research Department at the International Monetary Fund (IMF), and Gabriel Di Bella, Resident Representative, IMF in the Russian Federation.

In addition, the Committee members and coordinator participated in a number of meetings held by the Working Group on Financial Institutions and Capital Markets of the Foreign Investments Advisory Council (FIAC) and continued to collaborate with it. Also, Committee representatives took part in the seminar "Building the Russian green capital market" organised by the International Capital Market Association and Moscow Exchange in November 2018.

Tsyb, Deputy Minister of Industry and Trade, and contributed to development of a road-map for the industry initiated by Minpromtorg, and the process of amending technical regulation for coatings industry.

The Working Group member companies also seek to eliminate counterfeit products existing on the market and sold by their names.

The Commercial Vehicles committee (CVC) was founded at the end of 2008 as a spin-off of the Automobile Manufacturers Committee (AMC) in order to focus on specific needs of the commercial vehicles manufacturers in the Russian Federation. Main issues discussed within the Committee in 2018:

Development strategy of the motor vehicle industry until 2025

On 28 April 2018, the Chairman of the Government of the Russian Federation Dmitri Medvedev approved the Development Strategy of the Motor Vehicle Industry of the Russian Federation until 2025 by signing Government Decree No. 831-r dated April 28, 2018. The Committee states that it is necessary to:

- consider an effective market (real competition, transparent and predictable "rules of the game") as one of the criteria for successful implementation of the strategy;
- stimulate the establishment of alliances of Russian manufacturers with global industry leaders and support them;
- include detailed measures in the Strategy to create a supplier base and develop substantial government support measures for these suppliers;
- consider the efficiency of nationally produced commercial vehicles (in terms of fuel consumption, reliability, safety, etc.) as one of the key criteria for evaluating the successful implementation of the Strategy and stimulate it with government support measures.

Introduction of an electronic passport system for vehicles

Committee members are actively involved in the implementation of the electronic vehicle passport (EPTS) system and, together with all project participants, gradually carry out activities aimed at making a full transition to EPTS system when launching local production vehicles as well as and when importing cars into the territory of the Customs Union. It is necessary to ensure:

- the compatibility of the EPTS and electronic VTA systems in a dialogue with vehicle manufacturers;
- include information about the vehicle owner in the list of required fields for the EPTS;
- ensure uninterrupted operation of the EPTS system no later than six months before the expiry date of paper PTSs.

COMPLIANCE & ETHICS COMMITTEE

COMMITTEE ACTIVITIES, 2018

On 13 April 2018, the AEB Compliance & Ethics Committee, Human Resources Committee and IT & Telecom Committee organised a joint meeting entitled "New EU General Data Protection Regulation (GDPR) and its adaptation to local realities". The meeting provided a platform for the discussion of possible impact of the EU GDPR, which was adopted in 2016. The main topics discussed were: what is GDPR, GDPR as a part of European law reform – Digital Single Market, GDPR's application field communicated by ISACA and Roskomnadzor, GDPR's mechanisms, guidelines for SMEs on the security of personal data processing by ENISA.

On 12 July 2018, the AEB Compliance & Ethics Committee, HR Committee and IT & Telecom Committee held its open event "EU General Data Protection Regulation (GDPR): implementation experience". Regulation (EU) 2016/679, the European Union's new GDPR, governs the processing of personal data by any EU party. It also addresses the transfer of personal data outside the EU and EEA areas. The GDPR aims primarily to materially enhance the control by citizens and residents over their personal data and at the same time to simplify the regulatory environment for international business. The event provided a platform for discussion of the most important challenges in the process of implementing the GDPR. The feedbacks from the companies across the range of industries provided useful insights into the complex and often resource-intensive process for the Regulation's implementation. The meeting illustrated the numerous challenges for companies in the interaction between the GDPR and other laws and regulations (both EU and third countries), especially in domains where the co-existence of different requirements may create a conflict of organisations' legal obligations.

On 14 September 2018, the AEB Compliance & Ethics, HR, and IT & Telecom Committees took part in the video conference on EU GDPR with the representatives of the European Commission.

On 5 October 2018, the AEB open event "EU General Data Protection Regulation (GDPR): sharing best practices" was held. The event was jointly organised by the AEB Compliance & Ethics, HR, and IT & Telecom Committees.

The Construction Equipment Committee (CEC) was established in February 2008 to unite and represent the interests of the CE industry players in Russia.

Retail sales statistics are considered as crucial data by all CE manufacturers. The AEB Construction Equipment Committee's statistics programme has proven its efficiency since its inception in 2008. Today, such companies as Bell Equipment, Caterpillar, Chetra, CNH, Doosan, Hitachi, Hyundai Heavy Industries, JCB, John Deere, Komatsu, Kraneks, Liebherr, RM-Terex, Volvo are highly satisfied with the results of the programme. The reports are available within the Russian Federation at both the federal and regional levels. It is also worth mentioning that the Committee also started reporting on Kazakhstan in January 2014.

The main issues discussed within the Committee in 2018:

Disposal fee

In 2015, the market fell by 65% compared to 2014. In 2016, the decline continued and amounted to about 10%, partly because of the introduction of disposal fees. In 2018, the market grew by 31%. Still, this volume was on the level of 76% of 2013.

Nevertheless, the government introduced 15% increase of utilization fee in June 2018.

The Committee believes that, in the long run, the resulting increase in equipment prices will have a negative impact on the Russian economy. In the short term there is a threat that some types of equipment, especially those that do not have analogues produced in Russia, may disappear from the market.

Localisation

The Committee took active part and worked with the Ministry of Industry and Trade of the Russian Federation to amend Decree No. 719 "On approval of the criteria for classifying of industrial production to products which have no analogues produced in the territory of the Russian Federation, as well as the criteria for classifying industrial production to products produced in the territory of the Russian Federation." The work will be continued to allow optimal localisation levels in business operations, which are subject to the efficiency of capital investment and market conditions. As part of it, a working group within the Federal Antimonopoly Service was created to analyse Decree No. 719. The Committee will continue to cooperate with the Ministry of Industry and Trade to amend Decree No. 719.

The Committee collaborates with several national construction equipment industry associations. The AEB CEC is a member of the Committee for European Construction Equipment (CECE), and cooperates with the Korea Construction Equipment Association (KOCEMA).

COMMITTEE ACTIVITIES, 2018

The AEB Construction Industry & Building Material Suppliers Committee represents within the AEB a variety of businesses with very heterogeneous industrial and commercial backgrounds and with a diversity of interests but with the construction materials as a common bound. This Committee was established in 2010 in the belief that there are many matters that need to be monitored and shared and initially it was mostly addressed to producers of building materials.

In 2018, the Committee's efforts concentrated on building a common position on the following issues:

- application of the advanced construction technologies and materials for development of road infrastructure in Russia;
- fire safety in shopping malls;
- certification of cements, special types of cements;
- acoustic comfort standards in residential and commercial buildings;
- criteria for classifying objects that have a negative impact on the environment;
- protection of the Russian market from the counterfeited products;
- the lack of human resources and ergonomics in the construction industry;
- support for enterprises that collect and recycle used glass;
- the high cost of transporting materials and distribution of penalties for violating traffic rules;
- energy efficiency in construction;
- gas supply in Russia.

During 2018, the Construction Industry & Building Material Suppliers Committee and the Heating Systems Manufacturers Working Group held several joint events with the AEB Committees:

COMMITTEE ACTIVITIES, 2018

A consolidated presentation "Innovative development in plant growing: the main directions" on behalf of the CPC was made by the Committee Chairperson J. Brown at the Annual International Conference "Pesticides 2018" organised by CREON Chemicals on 26 September 2018.

Localisation of CPP production in Russia

CPC presented its consolidated position on the localisation of CPP production in Russia and its criteria at the meetings with A. Orlov, Deputy Head of Department of Chemical Engineering and Timber Processing Complex of the Ministry of Industry and Trade, in April and September 2018.

A consolidated presentation "Effective localisation of production of plant protection products in Russia" on behalf of the CPC was made by A. Basov, Committee Deputy Chairman, in the framework of the joint event of the AEB Committees "Localisation of production in agro-industrial complex: positive experience, conditions and barriers, criteria for specific industries" at the AEB Day in Krasnodar on 28 November 2018.

Anticounterfeit activities

On the CPC initiative the website protectorop.ru was created and launched in August. It is intended to provide information about current efforts to combat counterfeit CPP, legislative changes, effective measures, positive Russian and European experiences, and news.

Committee representatives continue their participation in the meetings held by the Expert Council on the State Commission on combating illegal turnover of industrial products.

CPC members have been working on studying and elaborating ways for implementation of infrared method to define counterfeit CPP supported by the European Crop Protection Association.

Container Management Scheme

A consolidated presentation was made on behalf of 2 associations – the AEB and the Russian Union of CPP manufactures – on the status and prospects of the process for the collection and recycling containers from pesticides in Russia "Ecologisation of pesticides' usage: positive experience of fulfilling the responsibility for the collection and recycling of pesticide containers by CPP producers" in the framework of the seminar organised by the Federal State Budget Institute "Russian Agricultural Centre" (Rosselkhoztsentr) in Voronezh on 8 February 2018.

COMMITTEE ACTIVITIES, 2018

On 21 February 2018, the 14th Annual Conference "Customs and business: 10 steps toward each other" was held in the Tchaikovsky Hall of the Four Seasons Moscow Hotel. Dmitry Cheltsov, Chairman of the AEB Transport & Customs Committee, and Head of the Eurasian Representative Office of IRU, moderated the Plenary Session. Frank Schauff, AEB CEO, delivered a welcome speech to the conference participants. Vladimir Bulavin, Head of the Russian Federal Customs Service; Timur Maksimov, Deputy Head of the Russian Federal Customs Service; and Leonid Lozbenko, Head of the Public Council of the Russian Federal Customs Service, also spoke at the Plenary Session. After the session, Frank Schauff signed the Declaration of recognition and support of the Charter of the good faith foreign trade participants. The CEO

pointed out that, by signing the Declaration, the AEB was acknowledging the need for initiatives and measures aimed at implementing anti-corruption programmes and conscientiously engaging in foreign trade. The Heads of the Federal Customs Service and the AEB concurred that the signing of the Charter by AEB companies was a good opportunity for them to demonstrate their support of the efforts of the Federal Customs Service and foreign trade participants aimed at creating favourable conditions for foreign trade and its sustainable development. The Charter is a form of collective agreement stating the commitment of businesses to perform foreign trade activities in a law-abiding manner. The customs authorities, in turn, foresee the possibility of providing additional simplifications and efficiencies for those undersigned.

On 14 March 2018, Mukai A. Kadyrkulov, Member of the Board, Minister for Customs Cooperation, Eurasian Economic Commission, gave a briefing that was organised by the AEB Customs & Transport Committee.

On 26 March 2018, the AEB Customs & Transport and Product Conformity Assessment Committees held an open event with Sergei Shklyaev, Head of Directorate on trade restrictions, currency and export control, the Federal Customs Service, and Sergei Migin, Deputy Head of the Federal Accreditation Service.

On 5 April 2018, the AEB Customs & Transport Committee traditionally organised a round table "Transport and logistics" within the Ninth Northern Dimension Forum, which was held in St. Petersburg. It was chaired by Alexey Mordashov, Chairman of the Board of Directors PAO "Severstal", Co-Chairman of the Northern Dimension Business Council, and Rolf Jansson, President and CEO, VR Group, Co-Chairman of the Northern Dimension Business Council (NDBC).

On 1 June 2018, the AEB Customs & Transport Committee experts participated in the final discussion of the draft Law "On customs regulation" before its first hearing in the State Duma. The meeting was chaired by Andrey Makarov, Head of the State Duma Committee for Taxation and Budget, and Iliya Trunin, Deputy Minister of Finance.

On 11 October 2018, the AEB Customs & Transport Committee held a meeting with Nikita Zolkin, Deputy Head of Tax and Customs Tariff Policy Department, Ministry of Finance.

AEB representatives took part in the International Customs Forum organised by the Federal Customs Service, which was held on 24-25 October 2018 in Moscow in the World Trade Centre.

On 22 November 2018, the AEB Customs & Transport Committee, Japan Business Club Customs Committee and Japan External Trade Organisation (JETRO) held its fifth annual round table to discuss actual issues in customs regulation and exchanged opinions on practical aspects related to risk management system, rating system of foreign trade participants, responsivity of a declarant for customs rules violation, technical regulation and certification systems in the Eurasian Economic Union. The AEB Customs & Transport Committee, JETRO and JBC agreed to continue the well-established constructive collaboration and regular meetings on an expert level.

On 11 December 2018, Dmitry Cheltsov, AEB Customs & Transport Committee Chairman, took part in the first meeting of the Public Council under the Federal Customs Service as a member of the FCS Public Council.

On 20-21 December 2018, the AEB organised an official visit to Germany for a delegation of the Eurasian Economic Commission (EEC), headed by Mukai A. Kadyrkulov, EEC Minister for Customs Cooperation, in order to share the best European practices in the field of customs regulation, namely, customs control, simplification of customs procedures, benefits of the status of an authorised economic operator exemplified by Porsche AG.

COMMITTEE ACTIVITIES, 2018

The AEB Energy Committee acts as an interface of business opportunities and issues of concern to European energy companies operating in the Russian Federation. Therefore, the Committee sustains and develops its links to relevant state authorities in Russia, such as the Russian State Duma, Ministry of Energy, Ministry of Finance and Ministry of Economic Development. The Committee also acts as an interface between the European energy business and Russian companies, such as Gazprom and others.

The AEB Energy Committee sustains its traditional cooperation with bilateral and multilateral entities in Russia, such as the International Business Congress (IBC), Petroleum Advisory Forum (PAF), Foreign Investment Advisory Council (FIAC), promoting active interaction on business-to-business and business-to-government levels. The AEB Energy Committee supports the AEB position as an official partner of the Annual Russian Petroleum and Gas Congress (RPGC) in Moscow and other events supported by the AEB through participation in its programme Committee, delegating its members as Chairmen and Speakers to RPGC. The Committee's activities are focused on energy policy strategic issues, investment climate, energy market conditions, and environmental protection issues, including global climate changes.

This year was marked by intense developing and enhancing of the working relations with the Russian State Duma Energy Committee started by the meeting with its Chairman, P. Zavalny. During the year the Committee members were regularly invited to the hearings and round tables organised by the State Duma Energy Committee.

In 2018 the Committee paid particular attention to tax issues having invited to its meetings the specialists from Big 4; the following questions were also in focus: the Russian gas delivery to European markets; Russia's upstream and downstream performance; Russia's gas strategy; Russia after Presidential elections; EU-Russia Climate and Energy Transition Dialogue; Russian legal framework for RE projects; implementation of power supply systems in remote and isolated areas.

The sanctions were also among the Committee's interests: at the CEOs breakfast V. Efremov, Partner, Baker McKenzie, made a highly appreciated by the participants presentation on "New and expected U.S. sanctions. Second wave of sanctions under CBW Act and DASKAA".

One of the important sources of information and influence tools for the Committee is its regular Position Paper, which is a highly professional document reflecting the views and approaches of the European companies towards the obstacles to making business in Russia and proposing real solutions. The Position Paper is widely distributed among petroleum and energy sector stakeholders both in Russia and abroad, including EU headquarters in Brussels.

The Committee advocates that EU-Russia relations on energy matters should be based on stability in strategic perspectives, mutual advantage and delivery of commitments. Such relations must include a balanced and transparent approach to the security and diversity of energy supply and demand, commercial attractiveness and reciprocity.

COMMITTEE ACTIVITIES, 2018

In 2018, the Energy Efficiency Committee continued to focus on four major work directions outlined in its annual Position Paper: coordination in the EE sphere; communication and PR on EE; technology transfer challenges; EE potential general assessment, as well as the need for additional tax incentives for the projects in the field of energy efficiency.

To keep the members informed about the recent developments in the field, the Committee hosted and co-hosted a series of policy briefings and events with the representatives of government bodies, including the following:

- the Russian State Duma Energy Committee Chairman P. Zavalny;
- Head of the Section at the Economic Development Ministry M. Nikitina;

• Round table "Waste management: practical experience and new in state regulations" (Deputy Head of the Department at the Russian Ministry of Industry and Trade).

For the second year in a row the Committee also closely cooperated with the Energy Ministry in organisation of panel discussion "How to develop cooperation between Russia and EU in the field of energy and energy efficiency" at the Russian Energy Week. Speakers of the panel representing the Committee included E. Benedetti, Signify, and B. Chalabi, Committee Chairman, Promaco TR. The event was attended by the Deputy Ministers from the Russian Ministry of Foreign Affairs and the Russian Energy Ministry.

COMMITTEE ACTIVITIES, 2018

One of the Committee's key projects in 2018 was the eleventh annual survey "Strategies and prospects for European companies in Russia". The survey has become a highly valuable source of first-hand information that provides an overview of the investment potential and opportunities in Russia and highlights the key challenges faced by AEB member companies, and the strategies adopted while doing business in Russia. The results of the survey were announced on the eve of the St. Petersburg Economic Forum: the official presentation was held on 22 May 2018 in Moscow and on 23 May 2018 in St. Petersburg. The survey and its results were well cited in the media. In November 2018, the Committee held a meeting to discuss how to increase a number of respondents to the survey.

Another important initiative was the publication of the AEB guide "How to invest in Russia". The publication was released on 1 November 2018. It provides updates on business, financial, legal, corporate, tax, environment and other aspects of investment as well as gives an insight into investments by regions and by industries, as well as into opportunities and challenges while localising in Russia. The magazine contains the foreword by Maxim Oreshkin, Minister of Economic Development of Russia, and features the article by the Federal Antimonopoly Service of Russia.

Among other key activities were regular updates on the sanctions and economy. In 2018 the Committee organised two open Committee meetings (in February and September) and three events (in April, May and December) devoted to

developments in the operating environment under the sanctions. Furthermore, Stuart Lawson, Finance & Investments Committee Chairman, participated as a co-moderator in the AEB North-Western Regional Committee event "Sanctions: overview, risks and challenges for European companies" (17 July 2018). The Russian economy and obstacles and perspectives for its development were also widely discussed at the traditional briefing by Boris Titov, Presidential Commissioner for Entrepreneurs' Rights (12 October 2018) and presentation of the report of the World Bank "A rebalancing China and resurging India: how will the pendulum swing for Russia?" (23 January 2018).

The Committee conducted a series of activities devoted to localisation issues: on 23 July 2018, the Committee held an open meeting on special investment contracts (SPIC) with the Industrial Development Fund's presentation with participation of interested Committees; on 29 November 2018, the event "SPIC or not SPIC?" was organised (jointly with the AEB Legal Committee) with participation of Sergey Vologodsky, Deputy Director, Industrial Development Fund (IDF), and Maxim Chereshnev, First Deputy Director General, Moscow Region Development Corporation. At the latter event Frank Schauff, AEB CEO, and Sergey Vologodsky, IDF Deputy Director, signed the Memorandum of Cooperation between the IDF and the AEB.

The important event was the 2018 FIFA World Cup Russia and ahead of it the AEB held the full-day conference "Get ready for the 2018 FIFA World Cup Russia!" (organised jointly by several AEB Committees) on 18 April 2018. The event comprised four different sessions and covered practical aspects of economic activities of the AEB member companies in different areas, such as: hospitality and accommodation, migration registration of guests, intellectual property rights, customs and transport, retail trade, construction industry and building material suppliers, legal and others.

In addition to the Committee events, Stuart Lawson, Finance & Investments Committee Chairman, participated as a speaker at the international conference "European investors in production projects in Russia" in the Ministry of Economic Development of Russia (30 November 2018) and as a co-moderator in the briefing by Gabriel Di Bella, Resident Representative of the International Monetary Fund in the Russian Federation, "Russia: recent developments and long-term perspectives" (4 December 2018) and the World Bank briefing based on the World Bank Russia Economic Report "In focus: Russia's economy: preserving stability, doubling growth, halving poverty – How?" (17 December 2018).

To cover leasing issues, within the Finance & Investments Committee there is the Leasing Subcommittee chaired by Maxim Lyalin, Leasing Subcommittee Chairman, Caterpillar Eurasia LLC.

In 2018 within the Leasing Subcommittee, one of the most discussed issues was Federal Law No. 398 dated 20.12.2017 "On amendments to the Federal Law 'On road traffic safety' in part of additional requirements to ensure road traffic safety while carriage passengers and goods by cars and city electric overland" (regarding corporate car fleet). The Subcommittee sent a number of letters, as well as prepared a legal alert on the issue (circulated among the AEB members). Furthermore, the Subcommittee held two open meetings for all interested AEB members (in July and October) in order to discuss and formulate actions to be taken. Several AEB members participated in the meeting organised by the Ministry of Economic Development of Russia and in the meeting with Irakliy Aslamazov, Head of Apparatus of the State Duma's Committee for Transport and Construction, and expressed the position of the business with regard to implementation of the Law. As a result of all joint efforts, the Law 386-FZ was signed on 30 October 2018 which made amendments in the Law 398-FZ (in part of corporate car fleet).

Another important topic within the AEB Leasing Subcommittee was discussion on reforming the leasing industry and the draft law amending parts one, two and three of the Russian Civil Code (introducing a new chapter on financial leasing in the Civil Code). In September 2018, the Subcommittee held a meeting with representatives of the Central Bank to discuss this issue.

Among other issues under discussion were countering fraud and checking counterparties, interaction with bailiffs, tax on movable property, sanctions, electronic passport, monitoring of leasing assets, debt collecting and others. The Subcommittee prepared a number of letters to state authorities.

COMMITTEE ACTIVITIES, 2018

In 2018 the following issues were on the radar of the Committee's activities: patient-oriented healthcare model; vital and essential medicines pricing methodology; OTC drugs advertising rules; localisation; implementation of medicines track and trace system; distant trade – to name just a few.

The Medical Devices Working Group was established within the Committee in 2018. The WG agenda and forthcoming activities will cover the following topics: medical devices registration and decriminalisation of process; localisation; SPIC 2.0; service contracts; trade-in model for state procurement; catalogue of goods for state procurement.

One of the Committee's major achievements in 2018 was the completion of a long-running project of setting clear rules for OTC drugs advertising. On 7 November 2018, the official presentation was held on the results of the cooperation between professional associations and the Federal Antimonopoly Service of Russia. This was followed by the signing of the Recommendations for legislative compliance regarding over-the-counter (OTC) drug advertising by professional associations and manufacturers. The aim of the document is to develop a unified practice for preparation of advertising materials and to create guidelines for pharmaceutical companies when working on advertising products. Apart from the AEB, the main professional pharmaceutical and communication associations took part in drafting the document. Andrey Kashevarov, Deputy Head, participated in the ceremony on behalf of FAS of Russia. The AEB was represented by Frank Schauff who signed the document.

In 2018 the Committee continued its dialogue with the major stakeholders: Roszdravnadzor, the Federal Antimonopoly Service, Ministry of Industry and Trade, and the State Duma Committee for Healthcare.

Committee members held a series of meetings with Sergey Tsyb, Deputy Minister of Industry and Trade, as well as the Centre for Advanced Technologies Development (CRPT) that was appointed an operator of traceability system, and discussed the implementation of track and trace project for the pharmaceuticals industry. The issue was also raised at the State Duma expert council meetings at which the Committee members were invited to speak.

On 25 September 2018, the Federal Antimonopoly Service held a round table "Big pharma's anticompetitive practices: BRICKs+ competition authorities' response" within the framework of the Week of Competition in Russia. Yuri Litvishchenko, Charmain of the AEB Health & Pharmaceuticals Committee, General Director, Chiesi Pharmaceuticals, and Ivan Glushkov, Deputy Charmain of the AEB Health & Pharmaceuticals Committee, Deputy General Director, STADA CIS, took part in the discussion on anticompetitive practices of global players. The event was chaired by Igor Artemiev, Head of the Federal Antimonopoly Service.

In 2018 the Committee enhanced the cross-committees cooperation. On 25 October 2018, a meeting on healthy living and increasing lifespan was organised by 4 Committees, namely, Heath & Pharmaceuticals, Food Processing, Retail Trade and SHES. The Committees agreed to continue cooperation on this matter in 2019 and prepare a Business Quarterly magazine. On 26 December 2018, the Committee members took part in the AEB meeting on traceability system in Russia. The meeting aimed at defining general position that can be conveyed to the state authorities.

In 2018 the AEB Home Appliances Manufacturers Committee among others focused on the issues, mentioned by the members as the most important – energy efficiency labelling, technical regulations, waste management, restriction of hazardous substances regulations, test management and independent product testing as well as enhancement of international cooperation.

In 2018 the AEB became a member of the International Roundtable of Household Appliance Manufacturer Associations (IRHMA) – an informal global forum within which the household appliance industry can discuss global challenges and issues. The Roundtable brings together representatives of home appliance sector from across the globe.

In 2018 the Committee held a series of CEO-level and expert-level meetings. Apart from this, the Committee members were involved in discussions of household appliance testing methods with the representatives of Roskachestvo (Russian Quality Testing Organisation) and the Eurasian Economic Commission. The representatives of the Committee spoke at the 3rd WEEE Solutions Congress and discussed recent trends of household appliance recycling trends.

COMMITTEE ACTIVITIES, 2018

On 18 May 2018, the AEB Hotels & Tourism Committee participated in the meeting which was dedicated to the migration registration of guests accommodated in the hotels, and implementation of the electronic system in hotels to transfer guests' data to the Ministry of Internal Affairs for the migration registration purpose. The meeting was chaired by Vladimir Chernikov, Minister of Moscow Government, Head of Moscow Department of Regional Security and AntiCorruption, and Dmitry Sergeenko, Head of Migration Directorate of the Ministry of Internal Affairs of Russia in Moscow. During the meeting, the hotels' representatives addressed the questions concerning particularities of migration registration procedure of guests. Since there were a lot of questions related to the technical aspects of data transferring from a hotel to the Ministry of Internal Affairs of Russia, Vladimir Chernikov gave an order to the state-owned public enterprise "Moscow security" together with the Migration Directorate of the Ministry of Internal Affairs in Moscow to connect the hotels to the electronic data transmission system before the 2018 FIFA World Cup Russia.

On 16 May 2018, the AEB Hotels & Tourism Committee met with Rospotrebnadzor of Moscow. The meeting aimed to inform about the requirements of Rospotrebnadzor on sanitary legislation, consumer protection legislation for accommodation facilities, requirements for catering and medical services, as well as additional preventive measures to minimise epidemiological risks during the 2018 FIFA World Cup Russia. The meeting was chaired by Elena Andreeva, Head of Rospotrebnadzor of Moscow.

On 18 April 2018, the AEB organised the Conference "Get ready for the 2018 FIFA World Cup Russia!" which took place at the Metropol Hotel Moscow. Prior to the 2018 FIFA World Cup Russia, the AEB organised a full-day Conference comprising four different sessions which covered the practical aspects of economic activities of the AEB member companies in the different areas, such as: hospitality and accommodation, migration registration of guests, intellectual property rights, customs and transport, retail trade, construction industry and building material suppliers, legal and others. The plenary session was opened by Frank Schauff, AEB CEO, moderated by Armin Eberhard, AEB Hotels & Tourism Committee Chairman, General Director of Renaissance Moscow Monarch Center Hotel, and included the presentation of Andrey Pavlov, Head of Planning Department, and Oxana Tubman, Head of Accommodation Division of the Local Organising Committee. Nikolay Gulyaev, Minister of the Moscow City Government, Head of Moskomsport, spoke about the preparation of the city for the 2018 FIFA World Cup Russia, and Alexey Tikhnenko, Head of Hospitality Division, Moskomsport, informed about the main requirements for accommodation in Moscow hotels. Andrey Romankov, Deputy Head of the Department on Strategic Projects Development, Ministry of Telecom and Mass Communication, presented an important IT project -FAN ID. It is a unique project which was developed particularly for WC FIFA-2018 by Minkomsvyaz. Moreover, the FAN ID provides an opportunity for fans to come to Russia without visa. Thereafter, Irina Shvets, Head of the "Mosvolonter" Centre, informed about the programme of "City Volunteers for the 2018 FIFA World Cup Russia", the number of which was about 6 000 persons, which were involved in this programme in Moscow.

On 2 November 2018, the AEB Hotels & Tourism Committee members held a meeting with participation of Alexei Tikhnenko, Head of Hospitality Division, Moscow Government. They discussed the results of the 2018 FIFA World Cup Russia and further initiatives of the Moscow Government with regard to tourism development. The Hotels & Tourism Committee members expressed their gratitude for the fantastic Championship and the great and safe atmosphere in the Moscow city and in Russia as a whole. They also stressed the necessity of extension of the FAN ID for one more year and a free visa regime at least for 72 hours with a purpose of the tourism industry development in Russia.

COMMITTEE ACTIVITIES, 2018

The Human Resources (HR) Committee was established in 1995. At the present, there are five Subcommittees: the Assessment, Training & Development Subcommittee, the Compensation & Benefits Subcommittee, the Labour Law Subcommittee, the Recruitment Subcommittee, and the Relocation Subcommittee.

The Committee as a whole is committed to: developing Russia's HR market; lobbying for the members' interests with all necessary governmental and legislative bodies; keeping business circles and government institutions in Russia aware of

the current state of affairs in this area; developing solutions to the HR-related issues faced by foreign companies; promoting the exchange of experiences between foreign and Russian HR specialists; assisting AEB members in expanding their network and helping companies adapt, in general, to the Russian business environment.

The Committee keeps abreast of changes in the Russian labour market, including those influenced by the global economic situation, demographic trends, as well as amendments and additions to the country's legislation. Furthermore, the Committee works hard to contribute to the establishment and further application of the best international HR practices and standards in Russia.

On 13 February 2018, the AEB HR Committee held the 15th Jubilee HR Conference entitled "Team spirit 2018". The programme of the Conference was designed to demonstrate similar challenges with respect to strategic goals' achievement, typical for both big sports and HR global practices. The Conference's sessions were focused on the following topics:

- Formation of a global project team and the role of corporate culture for team performance.
- Building a high performing team from scratch.
- Agility in talent attraction, management and assessment.
- Motivation of an effective team: trends and automation paths.
- Russian salary market: main trends and future outlook.
- Digital C&B: why and how to create a useful salary review tool.
- Labour law. Rules of the game for the last season: who will get the yellow card?

The CEO panel "Interaction of CEO and HR Director" was a special session closing the event. The panelists discussed the influence of a productive relationship between CEO and HRD on business efficiency and achieving the company's strategic objectives.

In 2018, the Committee continued to develop cooperation with key state partners.

- The Committee strengthened its collaboration with the regulator the Central Bank (CBR), in particular with the Insurance Market Department at the Central Bank. The Committee is in regular communication with the Department. Representatives of the Insurance Market Department took part in the Committee events. In April 2018 the Committee held a meeting with Insurance Market Department representatives to discuss issues related to transition to Solvency Capital Requirements model. Vladimir Sukhinin, Deputy Committee Chairman, and Committee members regularly took part in the meetings and activities of the Central Bank's Expert Council on Insurance.
- The Committee continued its dialogue with the Ministry of Finance of Russia, in particular with the Department for Financial Policy, which usually reacts positively to proposals made by the Committee. Committee representatives took part in two meetings organised by the Ministry of Finance to discuss the draft law on branches of foreign insurers (reinsurers) in Russia in accordance with WTO obligations (held on 3 March 2018 and 20 September 2018). Representatives of the Department took part in the Committee events.
- The Committee continued to liaise with the Federal Antimonopoly Service of Russia (FAS Russia). Several Committee representatives are members of the Expert Council on the Protection of Competition in the Financial Services Market (section on the insurance services market) under the FAS Russia.
- The Committee continued its dialogue with the State Duma's Committee on Financial Markets and provided comments and proposals on draft laws related to insurance. Vladimir Sukhinin, Deputy Committee Chairman, is a member of the Expert Council for Legislation on Insurance under the State Duma's Committee for Financial Market, and took part in its activities.

In addition to the above, the Committee cooperated with other stakeholders at the Russian insurance market (All-Russian Insurance Association, Russian National Reinsurance Company, Russian Association of Motor Insurers, Association of Non-State Pension Funds (ANPF); Higher School of Economics, etc.). In 2018, most topical issues were the law sanation of insurance companies, the draft law regarding WTO and branches of insurance (reinsurance) companies, issues related to information protection, commercial risk insurance and many other. In December 2018, Nikolay Galushin, President, Russian National Reinsurance Company, took part in the Committee meeting.

On 24 May 2018, the AEB Insurance & Pensions Committee held its traditional fifth event on electronic insurance titled "Online solutions in insurance and pensions". The participants discussed recent trends and developments in online solutions in insurance and pensions in Russia, such as smart contracts, market place, blockchain examples, etc.

On 23 November 2018, the AEB Insurance & Pensions Committee held its regular pension event titled "New stage of pension reform: challenges and solutions". The event gave the audience an update on the pension reform, trends and solutions in corporate pensions, as well as on new products and technologies in the pension market.

In 2016, the AEB (represented by the Committee) joined the International Insurance Law Association/Association Internationale de Droit des Assurances (AIDA) as the Russian National Chapter. For this purpose within the AEB Insurance & Pensions Committee, the AIDA Insurance Legislation Working Group (AIDA Russian Chapter) was established. The Working Group is chaired by Capitolina Tourbina, Director, General Reinsurance AG. In 2018, within this framework the Committee held two events, namely: the open event "Sanation of insurers: potential risks and new opportunities" on 16 April 2018 (on the draft law on sanation of insurance companies and its main discussion points and concerns) and the round table "Branches of foreign insurance companies in Russia: in search of a balanced approach to regulation" on 12 November 2018 (on the draft law on WTO and branches of insurance (reinsurance) companies). Furthermore, AIDA Working Group Chair Capitolina Tourbina became Councillor at the President Council of AIDA.

On 29 March, 2018, the Intellectual Property Committee representatives took part in the briefing with Igor Artemiev, Head of the Federal Antimonopoly Service. Like in previous years, Mr. Artemiev provided comprehensive answers to the questions put forward by member companies of the AEB from different industries. These questions covered important topics regarding the regulation of the pharmaceutical industries, price monitoring, parallel imports, antimonopoly compliance, Federal Law "On protection of competition" and so on.

On 18 May 2018, the Intellectual Property Committee held a session "Parallel imports: in search of a balance of interests" at the St. Petersburg International Legal Forum. The Committee had been dealing with problems related to parallel imports for ten years and the speakers found it very important to express their position and to discuss this issue.

The purpose of the Committee's work is to create the right conditions for cooperation and joint development of digital technologies between Russia and the EU, followed by the mutual promotion of projects on the global markets; to combine EU and Russian capabilities to achieve synergies through enhanced technological cooperation.

Year 2018 was particularly fruitful and eventful for the IT & Telecom Committee – 6 open events for the AEB members were held, with two major marking points, the event on Big Data (almost a hundred persons attended the event) and a meeting with Y. Kontemirov, Roskomnadzor (the relations with this important governmental body were maintained and developed). The Committee members took part as speakers in the International Conference on Personal Data Protection on 8 November 2018. In the framework of this event, the Code of Good Practice in the Internet was signed. The Committee continued its contacts with the key Russian government stakeholders, authorities and business circles. After the AEB Strategy Meeting in January 2018 the Committee was designated as a leader in driving digitalization issues within the AEB (the round table "ABC of Digitalization" was organised in April 2018).

The Committee issued the second edition of the AEB Business Quarterly "Digitalization: a new way of life" in which the important topics were tackled: data protection and cybersecurity development; Russian government initiatives on digital economy; ICO markets; risks of using Big Data; HR issues in the IT market; retail digitalization; cloud technologies. V. Jourova, European Commissioner for Justice, Consumers and Gender Equality, addressed the problem of digital risks of the 21st century.

The Committee continued its cooperation with the European Commission. The Committee Chairman, Edgars Puzo, on 21-23 March 2018 took part in the AEB Board mission to Brussels where the AEB delegation met with Mariya Gabriel, Commissioner for Digital Economy and Society.

Having organised with assistance of the EU Delegation a video conference with the "International data flows and protection" unit of DG JUST, the Committee prepared questions on GDPR and E-privacy. During the two-hours event the ways for AEB members to comply with the GDPR without contravening Russian data protection legislation and other laws on information security (Data Localisation Law, Yarovaya Law and others) were discussed.

In 2018, the Legal Committee analysed the impact of sanctions on the Russian economy, political situation and investment climate as well as the legal novelties that appeared as a response to sanctions imposed by the U.S. and other countries. Such issues as amendments to antimonopoly packages and legislative initiatives by the Federal Antimonopoly Service, amendments to the Civil, Administrative, and Criminal Codes always attract attention of Committee experts. Parallel imports is another important topic reviewed by the Committee.

Apart from the speakers from the AEB, it gathered the representatives of the National Industrial Information Agency, Russian Association of the Special Technique & Equipment Producers; SPETSAVTOPROM; Karelian Trains.

On 10 April 2018, the Committee organised roundtable discussion of upcoming changes in migration registration procedure and law enforcement practice with participation of the Ministry on Internal Affairs representatives.

On 18 April 2018, the AEB organised the Conference "Get ready for the 2018 FIFA World Cup Russia!" which took place at the Metropol Hotel Moscow. Ahead of the World Cup FIFA 2018, which was held in Russia on 14 June – 15 July 2018, the AEB had organised a full-day Conference comprising four different sessions which covered the practical aspects of economic activities of the AEB member companies in the different areas, such as: hospitality and accommodation, migration registration of guests, intellectual property rights, customs and transport, retail trade, construction industry and building material suppliers, legal and others. The second session was devoted to the migration registration of guests during the WC FIFA-2018 and the planned amendments to Federal Law No. 109 "On migration registration on foreign employees in the Russian Federation" (FZ-109). The session was moderated by Ludmila Shiryaeva, AEB Migration Committee Chairperson, Government Relations Director, EY. Alexander Aksenov, Deputy Head of Chief Migration Directorate, Ministry of Internal Affairs of Russia, and Kirill Adzynov, Head of Work Permit and Visa Department, Ministry of Internal Affairs of Russia, were

distinguished guests of the session to brief on the forthcoming changes to FZ-109 and regulations relating to migration registration during the 2018 FIFA World Cup Russia. Alexey Filipenkov, AEB Migration Committee Deputy Chairman, Partner, Visa-Delight, made a presentation on practical experience of migration registration procedure during the Confederations Cup 2017 and gave recommendations to the Conference participants for the 2018 FIFA World Cup Russia.

On 6 July 2018, Frank Schauff, AEB CEO, Liudmila Shiryaeva, AEB Migration Committee Chairperson, and Alexey Filipenkov, AEB Migration Committee Deputy Chairman, met with Alexander Aksenov, Deputy Head of Chief Migration Directorate, Ministry of Internal Affairs of Russia. Among other participants were: Igor Dudnik, Deputy Head of the Moscow city Migration Directorate, Andrei Kostorei, Deputy Head of the Moscow region Migration Directorate, as well as other representatives of migration authorities. The meeting was devoted to the practical implementation of new rules of migration registration procedure for foreign employees in the Russian Federation, which were adopted by Federal Law No. 163 "On amendments to the Federal Law of migration registration of foreign citizens" on 27 June 2018 and entered into force on 8 July 2018.

On 10 October 2018, Ruslan Kokarev, AEB COO, Ludmila Shiryaeva, AEB Migration Committee Chairperson, Alexei Filipenkov, AEB Migration Committee Deputy Chairman, met with Andrey Kraushkin, First Deputy Head of Chief Migration Directorate of the Ministry of Internal Affairs of Russia. The participants of the meeting discussed the governmental Draft Decree concerning the procedure for the inviting party to apply measures for compliance by the foreign citizens with the purpose of entry. The Draft Decree was prepared to develop Federal Law No. 216. It was agreed to improve the text of the Draft Decree taking into account the AEB position which aimed to reduce the administrative burden on the employers.

On 5 December 2018, the AEB held XI Annual Migration Conference titled "Dialogue: migration law in practice" with participation of the representatives of the Chief Migration Directorate of the Ministry of Internal Affairs of the Russian Federation, and representatives of the Moscow and Moscow region Migration Directorates of the Russian Ministry of Internal Affairs.

The North-Western Regional Committee strives to offer its members the services and information equal to those the AEB offers in Moscow.

From more than 200 AEB members represented in the north-western region, about 108 companies demonstrated an active engagement in 2018 by regularly participating in the work of the Committee and its Subcommittees.

The year 2018 was marked by 14 notional open events and round tables held by the Committee and its Subcommittees.

The NWRC continued a good tradition of conducting an annual survey among its members on their satisfaction with the investment climate in the Leningrad region. The results of the survey were presented during the Annual Meeting with the investment team of the Leningrad region. In 2018 the Annual Meeting gathered a record number of participants – 85.

The Committee participated in the meetings of the Investment Councils of the Leningrad region and in the Advisory Committee under the Regional Customs Authorities (SZTU).

In 2018 the representatives of the AEB North-Western Regional Committee held several business meetings with the St. Petersburg city authorities and respective committees, as well as with the front-office for investors of St. Petersburg to draw up the future cooperation road-map and prepare the Cooperation Agreement to be signed between the AEB and the Government of St. Petersburg in 2019.

In 2018 the AEB also took part in the St. Petersburg Investment Forum which took place on 12-13 November 2018. The AEB CEO moderated the panel session of the Forum.

There were important meetings with the North-Western Customs authorities, the Labour Inspection of St. Petersburg, IMF, the World Bank, migration authorities, etc.

The Committee raised and discussed with responsible authorities such problems as:

- improvement of investment climate in the region;
- changes in the customs procedures and application of the customs legislation;
- parallel imports;
- localisation issues (including SPIC and RIP application);
- waste management practices and law application;
- sanctions and doing business in Russia in uncertain times;
- labour inspection audit;
- attracting, onboarding and retaining the employees;
- digital processes in the companies;
- transfer from share construction to project financing;
- challenges and forecasts in construction industry of the north-western region of Russia.

General Consulates in St. Petersburg and the European Union Delegation to the Russian Federation consider the AEB North-Western Regional Committee as an adviser and a reliable partner for European companies in the north-western region. The Committee continued fostering cooperation with the EU countries consulates in St. Petersburg through meetings with EU delegation representatives, meetings with the consuls general and commercial staff, organisation of events in cooperation with the consulates, presentations of AEB federal and regional activities during business breakfasts at the consulates, meetings with the national representative companies and potential members.

COMMITTEE ACTIVITIES, 2018

In June 2012, the AEB Technical Regulation and Standardisation Task Force became the Product Conformity Assessment Committee (PCAC). The Committee works in close cooperation with the Eurasian Economic Commission, the Committee for technical regulation, standardisation and conformity assessment of the Russian Union of Industrialists and Entrepreneurs (RSPP) and with the Delegation of the European Union to Russia and Directorate General for Enterprise and Industry of the European Commission.

In 2018, the Committee continued to focus on the issues of Standardisation, Accreditation, Conformity Assessment, Market Surveillance, as well as the harmonisation of industrial technical regulations of the Customs Union, representing maximum interest for the business, with the corresponding European documents.

The AEB Product Conformity Assessment Committee members will continue to collect major problems identified in the field of technical regulation and standardisation, especially in the frame of the EAEU.

PUBLIC RELATIONS & COMMUNICATIONS COMMITTEE

AIMS	The Committee brings together experts on PR, corporate communications and corporate social responsibility (CSR) from over 110 AEB member companies. Initially, the Committee was established to discuss topical issues, exchange information, and advise on the application of successful international PR practices in Russia. The interaction with traditional and new media remained an important part of the AEB Public Relations & Communications Committee's agenda in 2018. The Committee paid special attention to interaction with higher schools (Moscow State University, Higher School of Economics, Russian Academy of National Economy and Public Administration, Plekhanov Russian University of Economics, Moscow International Higher Business School MIRBIS Institute, RUDN University), and building partnerships with key business associations and communities.

On 21 March 2018, the AEB Public Relations & Communications Committee held its open meeting entitled "Key trends and challenges in global communications – new tools to promote and protect corporate reputation". The invited speaker Lars Erik Grønntun, Chairman & CEO, Europe, Middle East and Africa (EMEA), Hill+Knowlton Strategies, stressed in his presentation the importance of the Russian market to European business and investment, key trends in public affairs, crisis and corporate communications, and digital trends as the main platform for reaching customers, employees and diverse communities.

On 23 April 2018, the AEB Public Relations & Communications Committee and the AEB Human Resources Committee held a joint open meeting entitled "Corporate social responsibility (CSR) and sustainability in higher education and business: expectations and reality". The meeting served as a platform for the interaction between business community and higher schools representatives. In the closing part of the meeting, participants discussed the observations and facts presented by HR-services providers on the availability of vacancies on CSR & sustainability in the labour market.

On 26 June 2018, the AEB Public Relations & Communications Committee held its meeting entitled "Fake news, a realistic perspective". The invited speaker, Art Franczek, Professor of Accounting, American Institute of Business and Economics, delivered a presentation "Fake news, a realistic perspective". In his speech, Mr. Franczek focused on main categories of fake news, historical examples and their essence as regards big lie, misinformation and propaganda tools, little lies in the age of Big Data.

On 19 July 2018, the AEB Public Relations & Communications Committee held an open meeting with Dr. Xavier Emmanuelli, Founder of Emergency Medical Service Samusocial International and the co-founder of the organisation "Médecins Sans Frontières". Dr. Xavier Emmanuelli delivered the presentation "How to stay human in a megapolis. Importance of social support for the most excluded: the case of Samusocial International". In his speech, Dr. Emmanuelli stressed the interdependence of social stratification and social exclusion, interconnection of poverty and homelessness. The participants discussed the approaches to the problem of social exclusion in the Russian society, measures taken in this respect in Russia at a governmental level, and the organisations providing systematic approach to tackle this problem. On 25 September 2018, the AEB Public Relations & Communications Committee held an open event "Meet the media: TASS Russian News Agency". The event provided an opportunity to discuss the approaches towards planning of news content, working online, working with informational occasions and their promotion at the federal level.

On 13 November 2018, the AEB Public Relations & Communications Committee held an open event entitled "Go digital: social media for PR professionals". The event provided a platform for discussion of key trends in digital development in Russia and the ways to better integrate social media channels in the companies' ongoing communications plans.

On 11 December 2018, the AEB Public Relations & Communications Committee took part in the extended joint meeting "Business image of a company through the prism of reporting". The meeting was organised by the Russian Union of Industrialists and Entrepreneurs (RSPP) and aimed at exchanging the best practices applied by the European and Russian businesses in the field of sustainable development and non-financial reporting. The AEB representatives confirmed their interest in further development of the dialogue with RSPP in this regard.

The Committee is composed of a number of companies specialising in various areas such as environmental protection, health & safety, security & risk management. The Committee is divided into 4 subsections – the Security Subcommittee, the Environmental Subcommittee, the Health & Safety Subcommittee and the Climate Policy Working Group.

In 2018 all Subcommittees were proactive and organised 8 different events. The Environmental Subcommittee held a big conference on waste collection and processing with the participation of the representatives of the Ministry of Natural Resources and Environment as well as the Ministry of Industry and Trade.

The Security Subcommittee focused on digital protection and security checks matters. The Health & Safety Subcommittee held two round tables on fire safety due to the high importance of the issue for the business in 2018, and a round table at the Russian Health and Safety Week 2018 "European companies H&S best practices". The Committee traditionally participated in the round table "Ecology and circular economy" organised within the Ninth Northern Dimension Forum in St. Petersburg.

The Committee actively worked on enhancing cross-committees activities. For example in cooperation with the AEB Real Estate Committee, the Subcommittee organised the "Intersec Forum Russia" – first ever international forum related to security automation systems. Climate policy issues were actively discussed with the participation of the Energy Efficiency Committee.

In Q3 2018, the Committee prepared the Business Quarterly magazine "Safety, Health, Environment & Security".

In 2018 the Committee initiated a number of lobbying letters on issues that were of special importance for its members, including employees' medical checks legislation and implementation of the waste management legislation.

COMMITTEE ACTIVITIES, 2018

In 2018, the AEB Small & Medium-Sized Enterprises Committee's particular attention was paid to enhancing its participation in SME-focused external events, and to building partnerships with relevant federal authorities, in particular, with the Ministry of Economic Development of Russia, and with the following business associations: Chamber of Commerce and Industry of the Russian Federation (CCI), German-Russian Chamber of Commerce (AHK), American Chamber of Commerce (AmCham), Moscow Entrepreneurs Association (MEA).

On 23 May 2018, Tadzio Schilling, Chairman of the AEB Small & Medium-Sized Enterprises Committee, Associate Director, Business Development, EY, took part in the panel session "Readiness of Russian society, government and business for the digital economy" with the presentation entitled "European SMEs in Russia – partners for sustainable, inclusive and digital growth". The session was organised within the IV Russian Small and Medium-Sized Enterprises Forum (SME Forum) in St. Petersburg, which took place on the eve of the St. Petersburg International Economic Forum (SPIEF). The session was moderated by Dmitry Sazonov, Deputy Chairman, Committee of the State Duma of the Federal Assembly of the Russian Federation on economic policy, industry, innovative development, and entrepreneurship. The general discussion within the session encompassed the following topics: compliance of the Russian Federation's digital economy programme with the demands of business, the level of use, readiness of the government and Russian companies to transfer to digital technologies, economic and social aspects of digitalization.

On 2 October 2018, Tadzio Schilling, AEB SME Committee Chairman, took part in the First Forum of family entrepreneurs "Successful family – successful Russia!" organised by the Chamber of Commerce and Industry of Russia. In the session devoted to the experience of European countries in running family businesses – SMEs, moderated by Georgy Petrov, Counselor to the President of the Chamber of Commerce and Industry of Russia, Mr. Schilling delivered a presentation "Family businesses in the current economic environment. Between adaptation and disruption". The importance of family businesses to the European economy, due to their large share in Europe's GDP, cannot be underestimated. They are essential to growth and employment creation. The participants of the conference discussed the specifics of family businesses in Europe, including the historical aspects of their establishing, criteria for success, current driving forces and challenges related to digitalization, globalisation and localisation trends. The privileges for family SMEs in European legislation and financing terms were highlighted as the factors contributing to the favourable business environment for SMEs.

On 18-19 October 2018, the AEB Small & Medium-Sized Enterprises Committee took part in the SME business forum "Time for SMEs" organised by the Ministry of Economic Development of Russia and held in Krasnodar. "Time for SMEs" is a federal level platform aimed at boosting the dialogue between businesses and government at different levels. The two-day business programme encompassed the sessions attended by high-level speakers representing Russian federal and regional authorities, public and business associations, successful entrepreneurs and business coaches.

On 30 November 2018, the AEB Small & Medium-Sized Enterprises Committee took part in the AEB supported event – International Conference "European investors in production projects in Russia" co-organised by the Ministry of Economic Development of Russia, the Russian Foreign Trade Academy and the long-term integrated business partnership matchmaking programme "Russia-Europe: cooperation without frontiers" operated by the Moscow Entrepreneurs Association. In the session entitled "Current status and prospects of investment cooperation between Russia and EU countries", Stuart Lawson, Member of the AEB Board, Chairman of the AEB Finance & Investments Committee, Senior Advisor, EY, delivered a presentation "European companies' strategies in Russia". Ruslan Kokarev, AEB Deputy CEO – Chief Operating Officer, delivered a presentation "The role of the AEB in supporting foreign direct investments into the Russian economy".

The AEB Small & Medium-Sized Enterprises Committee took part in the VI International Conference "Foreign economic activities as a factor for efficient development of small and medium enterprises in Russian regions" held by the Ministry of Economic Development of Russia in Khabarovsk on 6-7 December 2018. In the plenary session, Paul Bruck, Deputy Chairman of the AEB Board, President, Most Service and Most Management, delivered a presentation "Positive trends in investment climate and reduction of administrative barriers. Continued hurdles for SMEs". In his speech, Mr. Bruck focused on positive trends in investment climate despite sanctions; importance of SMEs in the economy; SME structure in Russia; chances for SMEs in all areas of supply chain and professional services; continued bureaucratic barriers towards business set up. In the session organised in cooperation with the American Chamber of Commerce and the German-Russian Chamber of Commerce (entitled "Foreign businesses in Russia: challenges and perspectives") Mr. Bruck took part as a panelist.

The Taxation Committee deals with the most up-to-date taxation issues introduced by the Russian Government and proactively develops solutions in close cooperation with the Ministry of Finance and the Federal Tax Service.

In 2018 the Taxation Committee held 7 working meetings and 4 business events, which were of great value to the European and Russian executives. High-level representatives of the Russian Federal Tax Service, with whom the Committee had developed long-standing cooperative relationships, were invited to speak at the meetings and events. Daniil Egorov, Deputy Head of the Federal Tax Service, took part in the Semiannual Conference on 6 July 2018 and discussed international taxation issues with the Committee members.

The Committee identified taxation issues that were of great concern for international companies – VAT on e-commerce, application of beneficial ownership concept, economic justification of expenses for taxation and tax control purposes, application of Article 54.1 of the Russian Tax Code, to name just a few, and addressed them to the state authorities.

The Committee was active in terms of joint activities with the AEB working structures and partners. In cooperation with all interested Committees, the Taxation Committee prepared a query to the Governors of 34 regions of Russia regarding movable property taxation starting from 2018 and received respective replies from almost all regions. The Committee also held a workshop on taxation issues at the AEB Day in Krasnodar and participated in the RSPP's project – "Corporate Taxation Award".

In October 2018, the Federal Tax Service established the Foreign Investors Advisory Council under the supervision of Mikhail Mishustin, Head of FTS. The Council comprises the representatives of major business associations standing for foreign investors operating on the Russian market, and the AEB Taxation Committee was invited to take part. The Council was established in order to have a dialogue between the leadership of the Federal Tax Service and the representatives of foreign investors, and conduct joint work on improving the business climate in Russia. The Council will meet on a regular basis and will discuss the most topical tax legislation application issues.

The Committee initiated and published the following alerts: on movable property tax exemption extension status in selected regions of the Russian Federation in 2018-2020 (13.06.2018); on the AEB position regarding the guidance on beneficial ownership confirmation issued by the Federal Tax Service (12.07.2018); on the Federal Tax Service Foreign Investors Advisory Council (02.11.2018).

WORKING GROUP ACTIVITIES, 2018

On 5 April 2018, the AEB Working Group on Modernisation & Innovations held its round table entitled "Energy. Digital technologies in energy", which was organised within the Ninth Northern Dimension Forum in St. Petersburg. The event was moderated by Michael Akim, Chairman of the AEB Working Group on Modernisation & Innovations, Vice President on Strategic Development, ABB Russia.

On 16 October 2018, the AEB Working Group on Modernisation & Innovations held its panel session entitled "The revolution in the development of transport. Will digitalization and greening lead to a change of business model?", organised within the Open Innovations Forum 2019. The session was moderated by Michael Akim, Chairman of the AEB Working Group on Modernisation & Innovations, Vice President on Strategic Development, ABB Russia. The panelists to the session discussed the following topics: megatrends of interdependence of the new generation technologies applied in transport, urban planning, and energy supply systems; prospects for the development of environmentally friendly transport in Russia: electric vehicles, electric buses, commercial and freight electric transport; main mechanisms of state support at legislative, regulatory and administrative levels in terms of widespread use and production of environmentally friendly transport in Russia, including both road and rail, water, and air transport.

On 29 October 2018, the AEB Working Group on Modernisation & Innovations held its open event – a round table entitled "Labour productivity in Russia". The event aimed at discussing the governmental policies to improve labour productivity in Russia, and the practical steps that could be made by businesses to solve productivity issues. The participants discussed the priority programme on the increase of labour productivity in Russia, practical aspects to contribute to the improvement of productivity in Russian businesses, and the impact of technological progress on labour demand in terms of the opportunities and challenges related to automation processes.

On 14 December 2018, the members of the AEB Working Group on Modernisation & Innovations took part in the meeting with Grigory Trubnikov, First Deputy Minister of Science and Higher Education of Russia, organised by the EU Delegation to Russia. The meeting provided a good opportunity for getting comprehensive first-hand information and for discussing Russia's new national project "Science" and Russia's new State Programme for Science & Technology Development, and to discuss Russia's priorities in this field.




