## TOTAL IN NENETS DISTRICT (RUSSIA): GEOGRAPHY AND BUSINESS



### **NENETS AUTONOMOUS DISTRICT - GEOGRAPHY**

- 176 810 km<sup>2</sup> (env.1% of the Russian territory)
- Population
  42.8 thousand
  (0.24 per km<sup>2</sup>)
- Capital Naryan-Mar (population appr. 25 thousand)
- Most of the territory is situated beyond the Polar circle
- No permanent interregional roads



- Cold climate, very long winter (220-240 days) with heavy snow and winds
- Large zones of permafrost
- Village of Khorei-Ver (the closest to Kharyaga field about 80 km) has 740 inhabitants, half of them Nenets





### **NENETS PEOPLE**

- Samoyedic people living along the Arctic shore of Eurasia, from Kola peninsula to Taimyr peninsula
- traditional way of life nomadic reindeer herders
- about 40 thousand, mostly in YaNAO and NAO
- In NAO –
  7.7 thousand
  (18.6% of the district's total population)



- In Nenets autonomous district, most Nenets families live in villages, with men working shifts with reindeer herds on their seasonal routes in the tundra; however, there are still nomadic families living in the traditional *chum*
- Every reindeer herders' cooperative or independent family has its traditional pastures along the seasonal route (mostly from SW to NE in the spring and summer, and back to SW in the fall)

#### **KHARYAGA PSA**



- Levels 2 and 3 of Kharyaga oilfield (the rest of the field is operated by Lukoil)
- Highly paraffinic oil (freezes at +29°C!), H<sub>2</sub>S in associated gas
- PSA was signed in 1995 and became effective in 1995
- Production started in 1999
- Production in 2012: 1.537 MT
- Cumulative production since 1999: over 12 MT



- Federal
- Regional (NAO)

INVESTOR

- Total E&P Russie (40%, Operator)
- Statoil (30%)
- Zarubezhneft (20%)
- Nenets Oil Company (10%)

Profit Oil (what remains after recovering costs) is shared between the Investor and the State; the State's share is then shared between the Federal budget and the budget of Nenets Autonomous District



#### KHARYAGA PSA CONTRIBUTION TO THE BUDGET OF NENETS DISTRICT



Cash revenues provided by Kharyaga PSA to the regional budget include :

- Payments under the Art.16.5 of Kharyaga PSA "to cover the social and economic needs of the NAO population"
- Sales of the Profit Oil (NAO part)
- Local taxes

"... sales of the Kharyaga PSA Profit Oil amounted 5.6 billion rubles in 2012, constituting 36% of the revenues of the district budget..."

#### BENEFICIARIES OF SOCIETAL PROJECTS IMPLEMENTED JOINTLY BY KHARYAGA PSA INVESTORS

- "Put' Il'icha" reindeer herders' cooperative, Khorei-Ver
  - Khariaga oilfield is situated in the area of reindeer pastures historically belonging to families descendants of which are now members of the cooperative (the land was actually assigned to the local oil producing enterprise back in the 80s; Kharyaga PSA site is in the middle of the oilfield, surrounded by the sites operated by Lukoil)
- School №2, Naryan-Mar
  - Construction and furnishing of the new school building was financed jointly by Total and Statoil (completed in 2009)
  - The school is a public educational institution
  - Kharyaga PSA investors continue to provide "extra" benefits to the school and its students (donation of equipment, funding for students' educational trips, etc.)
- Children's Art School, Naryan-Mar
  - The school is a public after-school educational institution
  - Kharyaga PSA investors provide "extra" benefits to the school and its students (donation of equipment, funding for students' educational trips, etc.)
- College of Social Sciences and Humanities "Vyucheisky", Naryan-Mar
  - The college is a public educational institution and offers secondary-level education and vocational training for nurses, kindergarten teachers, IT technicians, postal service operators

## CASE 1 NAR'YANA MYA: "ON-THE-JOB TRAINING"



#### «NAR'YANA MYA» ("RED CHUM"): BACKGROUND



Annual medical missions to remote tundra areas

- Public health system in Nenets district includes the central regional hospital in Naryan-Mar, an outpatient clinic located in Naryan-Mar area, and small medical facilities in the villages
- In emergencies, a helicopter is sent from Naryan-Mar with a medical team to provide treatment or bring the patient to the regional hospital.
- Most of the tundra villages have resident nurses; some have doctors as well, but these are general practitioners, not specialists.
- Reindeer herders in the tundra are mostly on their own; they have satellite phones to call the village or Naryan-Mar in case of emergency, but the communication is unstable, especially in heavy snow or rain. It makes first aid skills extremely important.



### «NAR'YANA MYA» ("RED CHUM"): BEGINNING





The project started in 2008 in Bolshezemelskaya tundra (in 2002-2008 there was a similar project in Kanin tundra)

- Main goal: to improve the healthcare of the nomadic Nenets population
- Participants: Lukoil Total E&P Russie Zapolyarny District Administration
- Medical team was flown by helicopter to remote tundra encampments, to perform medical check-ups, provide treatment and first aid training to reindeer herders and their families
- Funding for helicopter flights, doctors' and nurses' salaries was provided by Lukoil; Total purchased medical equipment and supplies

In 2009, the project was renewed, with a more diversified medical team

#### NAR'YANA MYA: LESSONS LEARNT IN 2008-2009

- The initiative proved useful: on each mission over 100 reindeer herders and their family members got medical check-ups, treatment and/or referrals to a hospital, clinic or specialists; first aid training was provided to reindeer herders and first aid kits distributed
- Equipment purchased for the project was then handed over to the outpatient clinic and used to provide medical care to the NAO population
- Good cooperation established between the two oil companies providing finance, supplies and logistics, on the one hand, and the local public health authorities, on the other hand

But:

• Limited number of patients could be reached by each helicopter flight (helicopter flights represent an important part of the total cost)

Ways to improve:

- The 2008 experience allowed to better define the requirements for the medical team; in 2009, endocrinologist, hematologist, pulmonologist, dentist were added to it and additional equipment was purchased
- For the future, it was deemed more efficient to send the mission to villages, where more people could be reached
- To reach both the nomadic people and the villagers, it was decided to move the mission from August to November-December (the reindeer slaughtering period, when the Nenets bring their herds to the villages)



### NAR'YANA MYA 2010-2011

2010: 631 patients in the villages of Kharuta and Khorei-Ver

2011: 560 patients in Khorei-Ver and Karataika

Lessons learnt:

- Importance of the information campaign
- Additional equipment needed; some of the existing equipment needs replacement
- Direct purchase of medical equipment and supplies by an oil company is not the best solution: the company lacks expertise to conduct a proper bidding procedure and evaluate offers, and single source purchase (from the supplier recommended by the local health authorities) lacks transparency

Total CSR in NAO - AEB CSR Event - Moscow - April 23, 2013

in the villages of Khorei-Ver and Nes':

- 972 medical check-ups performed, including 542 pediatric
- 42 patients referred to the hospital for further examination, 22 for treatment or surgery

NAO regional administration joined the project, allowing it to use the budget assigned to tuberculosis prevention program – in 2012, the medical team was equipped with a portable X-ray machine.

1 864 400 rubles (budget assignment)

Total cost of the project - 4 364 400 rubles (about \$140k), covered by:

1 500 000 rubles

1 000 000 rubles

Instead of purchasing medical equipment and supplies, Total E&P Russie donated funds to the local outpatient clinic and stipulated in the donation agreement that a part of the funds could be used to cover the costs of the proper purchase procedures (such procedures are now required for all major purchases by state entities).

Project will be continued in 2013

## CASE 2 FRENCH-RUSSIAN EXCHANGES: ESTABLISHING A PARTNERSHIP NETWORK



#### FRENCH LANGUAGE CENTER IN NARYAN-MAR

#### Long term partner: Association of French Language Teachers (Russia)

Total E&P Russie supports several programs of the Association, in particular:

- Operation of French Language Centers (in Naryan-Mar and Usinsk) offering French lessons to local residents free of charge or at affordable price.
- Linguistic training in France for language teachers
- Linguistic training in France for the best students of French

#### French Language Center in Naryan-Mar

- Opened in 2001 (the French Ambassador came to the opening)
- Operated by the Association of French Language Teachers using the funding provided by Total E&P Russie (the funding covers remuneration of the teacher and the linguistic trainings in France)
- The lessons are free of charge for the local residents; the Center gets to use the premises of the local educational facilities free of charge
- Total E&P Russie provides assistance on a regular basis, sending equipment, books, periodicals, films and creating opportunities for contacts with native speakers (company's staff coming to Naryan-Mar on business trips)
- Since 2011, the students of School#2 are offered an elective course in French





#### FRENCH LANGUAGE CENTER IN NARYAN-MAR

- About 250 students in 11 years (some of them stay on for several years) – don't underestimate this number, as it represents 1% of the total population of Naryan-Mar!
- 30 linguistic trainings in France



10<sup>th</sup> anniversary of the Center - March 2012

#### Latest developments

- In 2013, thanks to the NAO Administration support, the Center expects to get a permanent classroom on the premises of the Nenets Regional Center for Development of Education
- In 2013, the French Institute in St.Petersburg will organize the first qualification exam in Naryan-Mar (program supported by Total E&P Russie)



#### FRENCH INSTITUTE (St.Petersburg) PROGRAMS IN NARYAN-MAR

#### Long term partner: French Institute

The French Institute is a cultural institution of the French Embassy in Russia. Its programs are financed by the French Government and sponsors' donations. The French Institute (St.Petersburg) area of activity is the North-West Federal District, including, among others, Nenets Autonomous District.

Total E&P Russie supports a number of programs of the French Institute, such as French film festivals, exhibitions, concerts.
