# What is the AEB?

An independent, non-commercial organization based in Russia.

established in 1995 on the initiative of several European companies, Ambassadors of EU member states and the Head of the Delegation of the European Commission to the Russian Federation

Mission: to promote the interests of its members by supporting them in doing business with and in Russia.

More than 600 members, mostly European companies, of which 100 operate in the North-West of Russia

# AEB in the North-West

- At the AGM in April 2009 a questionnaire was distributed to all present AEB members inviting suggestions of Russian cities to short-list for AEB regional expansion
- AEB members meeting on February 11, 2010: Foundation of AEB North-Western Regional Committee in St. Petersburg
- Elections of the AEB meeting in March 2010: Election of the Steering Group of the AEB North-Western Regional Committee
- Regular meeting of said Regional Committee
- In May 2010 first Open Committee Meeting for AEB members and non-members
- European and Russian Business Forum on September 23 – 25, 2010
- Opening of the AEB Regional office in St. Petersburg in 2011

- Active communication
  - Regular meetings and dialogue between the EU General Consulates of SPb, European Union's Delegation to Russia and representatives of AEB N-W Regional Committee
  - Topics: AEB member company feedback in N-W Russia, local and federal level negotiation processes with authorities, new working permit process, customs union, anti-corruption plan etc.
- Voice of European Businesses
  - Collection of needs and opinions of the EU business sector in N-W Russia to be utilized.
  - AEB N-W Regional Committee welcomes all the business environment related input of member companies.
