### BRYAN CAVE LEIGHTON PAISNER ADVISES TEVA ON SALE OF A YARSOLAVL PHARMACEUTICAL PLANT TO R-PHARM GROUP

**Bryan Cave Leighton Paisner, formerly Goltsblat BLP in Russia**, has advised Teva on selling a pharmaceutical plant in Yaroslavl Industrial Park (Novosjolki) to R-Pharm Group. The GMP-certified enterprise located on 19 hectares offers 13,000 sq.m. of production space. It manufactures medications for cardiological, neurological and endocrinological diseases.

The terms of the sale transaction include a five-year agreement under which R-Pharm will act as Teva's production partner in order to ensure continuous access for patients to Teva medicines.
