**Criteria for the rating of industrial production to industrial
production, which has no analogues produced in the
Russian Federation**

In accordance with the Federal Law of Industrial Policy of the Russian Federation “the Government of the Russian Federation decided to determine that:

1. The criteria for the inclusion of industrial production to industrial production, which has no analogues produced in the Russian Federation shall include:

a) the absence of production in the Russian Federation of these products, as confirmed in the order prescribed by the Ministry of Industry Trade of the Russian Federation taking into account:

requirements for industrial production imposed with a view to its inclusion in products produced in the Russian Federation, according to the appendix;

special investment contract (if any);

agreement on the Rules relating to the origin of goods in the Commonwealth of Independent States of 20 November 2009 in the absence of these products in the Appendix to this Decree);

b) the difference of the product’s parameters, relating to functionality or the list of functions, scope, quality characteristics (duration of the warranty period, the expiration date or service life, reliability, energy consumption,

ecological, physical, chemical, mechanical, organic properties that do not belong exclusively to the appearance of industrial products and significantly affecting the functionality, scope, or quality characteristics of industrial products) from the parameters of industrial products produced in the Russian Federation, as determined in the order prescribed by the Ministry of Industry and Trade of the Russian Federation.

2. The Ministry of Industry and Trade of the Russian Federation shall ensure the adoption of normative legal acts aimed at the implementation of the present Decree.

3. This Decree shall enter into force on 1 October 2015.
