



## **GRINBERG Ruslan Semenovich**

(1946) graduated from Lomonosov Moscow State University in 1968 with MA degree in Foreign Economics; he has a PhD degree from Plekhanov Moscow Institute of National Economy. From 1972 until 1981 he worked at the Research Institute of Price Formation supervised by the USSR State Committee on Prices (Goskomsen). Since 1981 he has been working at the Institute of International Economic and Political Studies of Russian Science Academy (IMEPI RAN) (currently – Institute of Economics of Russian Science Academy). He is corresponding member of Russian Science Academy. In 2003, he became a Director of the Institute of International Economic and Political Studies RAS, from 2005 to 2015 – director of Institute of Economics RAS, since 2015 - Head of Research of Institute of economics RAS.

R. Grinberg is known by important scientific studies concerning economic theory, economic globalization, economic and political issues in former socialist countries, and role of a state in modern economics. R.S. Grinberg's works were published in different countries, including England, Poland, Austria, USA, Germany and others.

Among his recent books is a monograph titled "Economic Sociodynamics" (co-written with A.Y. Rubinstein). This monograph presents a new concept in the economic theory. It was published in 2000 in Russia, and then in 2005 it was translated into English and published by Springer Publishing in USA and Germany, 2010 - the second Edition.

He has a number of prestigious awards - N.D. Kondratieff Gold Medal; awards from Vienna Institute for Advanced Studies for theoretical research in economic policy (Vienna, 2011); World Association for Political Economy, «For the contribution to the development of the economic theory» (Shanghai (PRC), 2013 ); Polish Economic Society «For the development of the Theory of Economic Sociodynamics» (Warsaw, 2013); Presidium of the National Academy of Sciences of Ukraine «For the development of the Concept of Economic Sociodynamics» (Kiev, 2013); Saint Petersburg State University diploma for "contribution to economic science advancement" (Saint-Peterburg, 24<sup>th</sup> of April 2014); diploma of the French Society of Macroeconomic Research and International Finance (CEMAFI) «For the contribution to the development of the theory of modern economics and social dynamics» (Nice, France, May 6, 2014); Italian Institute for Political, Economic and Social Studies EURISPES (Rome, October 2016) and many others.

R.S. Grinberg regularly participates in international scientific conferences in Russia and abroad.

## **YURGENS Igor Yurievich**

(1952) graduated with a degree in economics from Moscow State University in 1974, when he began working in various positions with the international departments of the Professional Unions Central Council of the USSR and the UNESCO Secretariat.

From 1992 to 1997, he was the First Deputy Chairman of the CIS Trade Union Confederation. He later served as Co-Chairman of the Foundation for the Development of Parliamentarism in Russia (1997-1998). In 1998 he became President of the All-Russian Insurance Association (1998-2002).

From 2002 to 2005, Mr. Yurgens served as Vice President/Executive Secretary of the Russian Union of Industrialists and Entrepreneurs (RSPP). From 2005 to the present, he has been Vice President of RSPP.

Mr. Yurgens is the Chairman of the Management Board of the Institute of Contemporary Development, member of the Presidential Council for Civil Society Institutions and Human Rights, a member of the Academic Council of the Security Council of the Russian Federation, a member of the Board of Trustees of Russian Council on International Affairs, a member of the Presidium of the Council for Foreign and Defense Policy, a member of the Council of the International Institute for Strategic Studies (IISS), and a member of the Advisory Board of the Centre for European Reform (CER). In June 2013, Igor Yurgens was elected President of the All-Russian Insurance Association. In January 2015 he was elected President of Russian Association of Motor Insurers.

He is a professor at the National Research University's Higher School of Economics, where he regularly holds seminars on the particularities of government-business relations in Russia. Under the editorship of Igor Yurgens, a Risk Management textbook was published in 2003. He has also penned numerous articles and monographs.

He is the recipient of several state and international awards, including the Order of Honor of the Russian Federation, L'Ordre National du Mérite of France and the Russian Orthodox Church's Order of Saint Seraphim of Sarov and Order of Prince Daniel of Moscow, Order of Saint Charles.

Mr. Yurgens is also Honorary Consul General of Monaco in Moscow.
