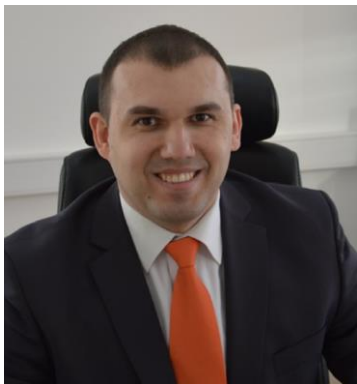

René Pischel studied mathematics in Kharkov, Ukraine in the former USSR, specializing in mathematical physics. At the Institute of Space Research in Berlin he received his PhD in the field of image processing.

Work Experience

Since 1992 René Pischel was affiliated with the German Space Agency (DLR) Institute of Space Sensor Technology and Planetary Exploration in Berlin, starting from 1994 as a Section Head. His professional career was closely tied to Mars exploration and in particular to the German High Resolution Stereo Camera (HRSC) which was initially developed for the Russian Mars 96 mission and was flown later on the Mars Express mission of the European Space Agency (ESA). In 2003 he was seconded by DLR to ESA/ESTEC in Noordwijk, Netherlands for the coordination of science operations of this ESA planetary mission.

René Pischel joined ESA in 2007 and became Programme Activities Coordinator in the ESA Permanent Mission in Moscow in August 2007.

Since 2009 he has been representing ESA in Russia in his position as Head of the ESA Permanent Mission in the Russian Federation.

René Pischel has been member of the AEB Auditing Commission since 2013.
