The contract value of the deal is more than **\$1 bn**, including options and aftersales services.

This is an important milestone for **CityJet** in expanding its fleet and a ground-breaking transaction for Sukhoi, as **CityJet** becomes the first Western European Airline to take delivery of a SuperJet. The new generation jet will fulfil **CityJet's** requirements for operating from airports in Europe, including London's City Airport, and offer significant advantages in fuel efficiency, emission ratings and noise reduction.

The first Sukhoi Superjet aircraft were delivered on 3 June 2016 in Venice, Italy, at the headquarters of SuperJet International. The nature of the transaction required many of the documents to be drafted from scratch, as there have been no precedent transactions for this type of aircraft.

The airline expects to receive three SSJ100s this year and the rest from 2017 onwards. Superjet International configured the **CityJet** aircraft in a 98-seat cabin layout with the interior designed by Italy's Pininfarina.
