

SELECTION PROCEDURE OF THE AEB TRAINING PROGRAMS PROVIDERS

TERMS OF REFERENCE

Since 2009 the AEB conducts an annual selection procedure among the AEB member companies with regard to participation in the "AEB Training" program (M2M open and corporate training programs). The results of the 2017 annual member survey will be given priority during the decision making process, amongst other criteria with regard to the training programmes calendar for 2017-2018.

All member companies interested in participating in the "AEB Training" program in 2017 and 2018 are invited to submit their Selection Proposal Forms.

Who is eligible to participate in the selection procedure:

Only the AEB member companies who have paid membership fees for 2017.

We kindly ask you to provide information **ONLY** through the Selection Proposal Form (please, **DO NOT** send detailed proposals, full description and outlines of the courses, as well as trainers' CVs and other attachments and links at this stage. These will be requested only from shortlisted candidates and for selected courses).

Deadline for company's offers submission is 18 July, 2017, 18:00.

Please note: All SPFs sent after the deadline will NOT be considered.



The selection process:

STEP 1: At this stage all SPFs will be reviewed and clarified. Within 4 weeks from the date of the deadline for submission of the bids, up to 30 courses¹ will be selected for inclusion in the 2017-2018 Open Training Calendar.

Key criteria for program selection are listed below:

- 1. Demand towards the course topic (based on the results of the member survey and the previous experience of the AEB and providers²);
- 2. Cost (based on the results of the member survey and previous AEB experiences);
- 3. Proposed financial conditions (discounts);
- 4. Feedback from the participants of previous AEB training programs (only for companies that participated in the previous AEB Training programs);
- 5. The company's experience in participating in the AEB Training program.

STEP 2: At this stage additional information will be requested from those companies, whose programs were selected for inclusion in the 2017 - 2018 Open Training Calendar (programs' contents, trainers' resumes, etc.).

STEP 3: At this stage, dates of the programs will be agreed upon with the selected providers.

STEP 4: At this stage the contracts with the selected companies will be signed (renewed).

Please note: Training courses will take place only if the minimum number of participants is registered.

All participants of the current selection will have an opportunity to participate in the selection for conducting corporate training programs.
