### Background to arbitration reform in Russia



- Increasing recognition of arbitration as a valuable dispute resolution mechanism
- Desire to promote arbitration in Russia
- Support the development of reputable Russian arbitration institutions
- Fight against so-called pocket arbitrations, kangaroo courts and other abuses of arbitration in Russia

## The new arbitration law imposes stringent conditions on arbitration institutions



- Special government authorisation requried
- Can only be established by non-commercial organisations (NCOs)
- Assessment of NCO's founders, activities, reputation etc. during authorisation process
- Detailed requirements for listed arbitrators

## Why choose the AEB Arbitration Court over arbitration abroad?



- The AEB Arbitration Court can be an alternative to arbitration abroad when e.g.:
  - The size of a dispute or its connection to Russia makes arbitration outside of Russia unnecessarily costly or otherwise unwarranted
  - There is a particular need (e.g. due to the subject matter of the dispute or the location of the counterparty's assets) to obtain an arbitral award which will be recognised and enforced in Russia
  - Russia is the only location for dispute resolution which the counterparty finds acceptable
